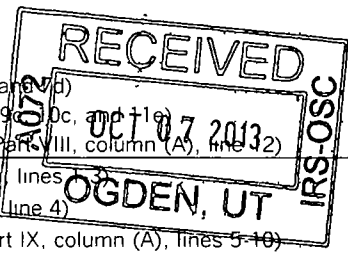

- NOTE 1 – **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**
The financial statements and notes are representations of the Corporate management, who are responsible for their integrity and objectivity. The accounting policies conform to generally accepted accounting principles and have been consistently applied in the preparation of the financial statements.
- NOTE 2 – **ACCOUNTING BASIS**
The books and records of the corporation are prepared on an accrual basis of accounting for both financial reporting and income tax purposes.
- NOTE 3 – The corporation was organized in New York State and is a non-profit organization exempt from tax under IRS code section 501 (a) 3. The corporation operates a summer camp for girls grades 7-12. The camp is located in Woodbourne, N.Y. and accommodates 320 girls including girl counselors.
- NOTE 4 – **ACCOUNTS RECEIVABLE**
Accounts receivable represent fees due from campers which were deemed to be fully collectible.
- NOTE 5 – **LAND, BUILDINGS, & EQUIPMENT**
Land, building, and equipment are owned by the corporation and are stated at cost. The buildings and equipment are being depreciated using the accelerated cost recovery method over the estimated useful lives of the respective assets.
