The organization provides primary healthcare to a predominantly uninsured and underinsured population in its two locations. During the company's last fiscal year, the clinics served nearly 7,317 patients and provided 18,293 patient visits. The clinics together provide family medicine, pediatrics, and OB/GYN services and collaborate with other area organizations and specialists to ensure comprehensive care for its patients.

During the year the organization was given a grant from the State of Texas for Family Planning Program We provided services to the Private patient population We saw 1,268 Patients a total of 1,739 Visits
