**ALLOCATION OF GRANT ADMINISTRATIVE EXPENSES**

Basis used to allocate administration expenses to charitable activities:

With respect to the allocation of expenses for purposes of the computation of net investment income, it has been the practice of the foundation to claim as deductions one-half of the accounting fees incurred in the preparation of the foundations's tax and information returns and related matters, fees charged by brokerage firms (other than commissions which are taken into account in the capital gains computations), filing fees paid by the foundation and other expenses incurred in preparing the foundation's returns and otherwise satisfying the various Federal and state filing requirements.

With respect to the allocation of expenses for charitable purposes, it has been the policy of the foundation to allocate all legal and related fees, administration fees incurred in advertising the existence of the foundation (eg: membership in exempt organization societies, etc.) and other non-investment related costs (i.e.: P.O. box rental) entirely for exempt purposes since such expenditures relate directly to the furtherance of the exempt purpose of the foundation.
