During the six months short year, MDNA has had 7 admissions and 16 discharges including 1 death. MDNA nurses have called the ambulance 1 time on behalf of patients. A total of 73 patient visits were made to the office. This number does not include all the visits from persons borrowing Loan Closet Equipment. The Loan Closet provided durable medical equipment to 67 Mount Desert Island residents, for a total of approximately 109 pieces of loaned equipment. Most of this equipment is returned within a few weeks or months and then needs to be cleaned and restocked into the basement.

In addition to the 641 regular patient care visits, the nursing staff spends many hours conferencing with health care professionals, individuals, and families by phone. During the year our RNs have made
