WE PROVIDED SCULLING AND SWEEP ROWING PROGRAMS FOR MEMBERS RANGING FROM HIGH SCHOOL FRESHMEN TO MEN AND WOMEN IN THEIR 70'S. IN THE SUMMER WE RAN LEARN-TO-SCULL INSTRUCTIONAL SESSIONS FOR 10 PEOPLE, AND LEARN-TO-SWEEP INSTRUCTIONAL SESSIONS FOR 11 PEOPLE. IN JUNE, WE HELD A FREE LEARN-TO-ROW DAY TO INTRODUCE COMMUNITY MEMBERS TO ROWING, WITH ABOUT 30 PARTICIPANTS. FOR HIGH SCHOOL MEMBERS, WE OFFERED THREE 2 WEEK SESSIONS IN THE SUMMER FOR BOTH NOVICES AND HIGH SCHOOL ROWERS WITH EXPERIENCE. NOVICE ROWING, TECHNIQUE AND FITNESS, RACING. 29 JUNIORS PARTICIPATED IN THOSE PROGRAMS. IN THE FALL, WE OFFERED A 6 WEEK RACE-ORIENTED PROGRAM FOR 36 HIGH SCHOOL STUDENTS FROM AROUND THE AREA. 2012 WAS OUR SECOND YEAR OFFERING A POPULAR 2 MONTH SPRING ROWING PROGRAM FOR LEBANON AND HARTFORD HIGH SCHOOL STUDENTS, WHO PROGRESSED TO RACING OTHER SCHOOLS IN THE REGION.
