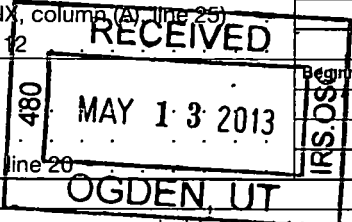

Our mission is to provide financial support for, and advice to, Gethsemane Garden Christian Centre, a Christian boarding school in Western Kenya, which provides housing, clothing, food, medical care, and a quality education to over 500 students (over 80% are orphans) from the Suba Tribe. The school is located on Mfangano Island in Lake Victoria.

During fiscal year 2012, the organization made grants of \$494,593 to Gethsemane Garden Christian Centre in Kenya. These grants were made possible through charitable donations from a donor base of over 400. The Christian boarding school has over 500 students from Kindergarten through Grade 12. Grants in 2012 were made for monthly operational expenses and capital expenses associated with the Lower and Upper Schools. A detailed listing of the grants and the uses can be found in Schedule F attached to this return. Our organization makes on-site visits on at least an annual basis (normally more often) and requires the Kenyan school to undergo an annual audit by a reputable CPA firm from Nairobi, Kenya. In 2012, the Upper School (High School) main building was completed and a water project was underway to provide clean drinking water to the school as well as the surrounding community. Other grant funds not used for capital expenses go to support the monthly operational expenses of the school which generally cost approximately \$80.00 per student. The school also receives funds through the PEPFAR program which is administered through the Elizabeth Glaser Pediatric AIDs Foundation. No revenue is shown above since the program service itself did not generate revenue but was supported by contributions. The first class of 41 students will graduate in early 2013.

The organization conducted a Mission trip to the school in 2012 with 25 team members from the United States augmented by others from the Tenwek Missionary Hospital in Kenya. This two-week trip included construction, medical care, and interaction with the school's staff as well as the Kenyan board. The expenses for this trip are listed in Part IX and broken out in Schedule "O".

**Part III, Lines 2 & 4b:** During 2012, the organization conducted a mission trip to the school/orphanage in Kenya with 25 team members from the United States during which program services were delivered including construction, medical, optical, financial assistance, and general interaction with the 569 students and staff of over 70. The expenses incurred are shown in gross form in Part IX on Line 24d as \$102,345.

The expenses break down as follows:

International & Domestic Flight Support: \$65,810; Travel Insurance: \$675; Visas: \$1,250; Freight \$1,078; Ground Transport: \$3,113;

Even though some donations are \$75.00 or more, the donor receives a tax exemption receipt for the full amount of their gift since there is only an indirect relationship between the meal and the gift and there is no quid pro quo. For the 2012 Charlotte dinner, we did ask attendees to pay \$25.00 to defray the cost of the meal and no tax exemption certificates were issued for those receipts.
