ministry will have to carry a mortgage note of the purchasers for a period of time. It is  
thought that Columbus Community Bank will agree to the additional financing within 18 to 24  
months. No other financial institutions were willing to fund the transaction. Accordingly,  
terms (interest rate, term, etc.) of the mortgage note held by the ministry are identical to  
the terms of the mortgage note held by the independent bank. Additionally, in accordance with  
the IRS communication referred to above, two independent and professional appraisals were  
obtained for the acquired properties, with the purchase price being an average of the two
