International Ministry (Excludes compensation reported Part IX, Lines 5 & 7) Gospel for Muslims works through a non-governmental  
organization (NGO) in Bangladesh with the purpose of engaging in community transformation through eradicating poverty,  
eradicating illiteracy and establishing God-fearing communities. The organization provides services to over 10,000 families in rural  
parts of the country who are members of the NGO. Micro-loans are distributed to those in poverty to assist rural entrepreneurs in  
coming out of poverty with dignity. The Clinic provides free medical visits to the NGO doctor and pharmacy with medicine provided  
at cost. 21 primary schools provide foundational skills and education to young children. Humanitarian aid such as food,  
mosquito nets, clothing and agricultural support for farmers meet physical needs to show the love of Christ. These acts of  
compassion provide opportunities to build relationships of trust with villagers. As relationships are built our ministry has the  
opportunity to share the Gospel message and disciple new believers.

Domestic Ministry (excludes compensation reported in Part IX, Lines 5 & 7) Gospel For Muslims equips Christian believers for  
outreach to Muslims through it's annual Muslim Background Believers (MBB) Conference (360 attendees in 2012) as well as through  
"GFM Institute" speaking engagements at churches across the nations (over 4,350 trained through 43 speaking engagements in 2012).  
The ministry also engages Muslim background believers in ministry to Muslims within their local communities.

GFM engages in prayer for Muslims through a weekly "prayer call" email communication that is distributed to over  
2,400 contacts each week.

Gospel for Muslims takes Christian volunteers on mission trips to Bangladesh where they support the work of the ministry there  
through sharing the Gospel with villagers, discipling new believers and distributing humanitarian aid such as micro-loans, school  
supplies, mosquito nets, food and eyeglasses. In 2012 the ministry took volunteer teams (16 participants) on mission trips during  
the months of January-March, June-August and September-November.
