SINCE THE FOUNDING OF KGF IN 2005, OVER 500 CHILDREN HAVE BENEFITED FROM OUR PROGRAMS AND CURE RATES FOR CHILDREN WITH CANCER HAVE STEADILY IMPROVED. THE MOST DRAMATIC EXAMPLE OF THIS HAS BEEN THE CONTINUED SUCCESS OF THE NEW TREATMENT REGIMEN FOR ACUTE LYMPHOCYTIC LEUKEMIA (ALL), THE MOST COMMON FORM OF CANCER AMONG CHILDREN.
