Membership: Through memberships, the HR YMCA pursues its goal of improving the health and well-being of the community and supporting its neighbors. We are 6355 members strong (as of December 31, 2012). In keeping with the YMCA's mission, financial assistance is provided on a sliding scale based on income guidelines: 5.3 percent receive financial assistance through our "Membership for All program." Through membership, individuals and families throughout the Pioneer Valley have access to all of the YMCA's facilities and adult classes at no extra cost. Health and wellness programs are an essential part of our mission and they stress the value of good exercise and health habits. Our health enhancement programs include free wellness consultations with our staff and the Y-Connect program, which tailors a fitness plan to help members meet their goals. Members may also opt for fitness assessments and personal training at a low cost. The facilities available to members include our wellness floor with state-of-the-art cardio and weight lifting equipment, a separate free-weight room, a stretching room, a 6-lane, 25-yard indoor pool, a shallow, warm-water pool, a gym with basketball courts, a racquetball court, family locker rooms, and adult-only locker rooms with saunas and steam rooms. We also provide extensive childcare to help parents take advantage of our facilities. (continued to schedule O)

Other programs: The HR YMCA offers a wide range of programs, primarily for youth, to members and non-members for a fee. The primary goals of our youth programs are to foster growth and development in children and to help them develop positive values, self-esteem and leadership skills. Our instructors and coaches create a non-competitive and encouraging environment while promoting the YMCA core values of honesty, responsibility, caring, and respect. Our programs also create a place for families to meet friends and create supportive communities. Youth classes include dance, gymnastics, intro to sports, basketball, martial arts, and fitness training. Our aquatics programs include children as young as 6-months-old, and we offer extensive array of swim lessons for all ages and abilities. Kids who want to participate in team sports at the YMCA can choose from gymnastics, swimming, and basketball. Our swim and gymnastics teams participate in meets with other teams from around the region, while basketball is an intramural league, where teams are all from the HR YMCA. In 2012, 1571 youths participated in our aquatics programs, 1122 in gymnastics and dance classes, 395 in youth sports, and 98 on the gymnastic teams, and 124 on the swim team.

Camp Norwich: The HR YMCA offers the quintessential summer camp experience through Camp Norwich, available to both members and non-members. Camp Norwich's mission is to help campers develop self-confidence, teamwork, an appreciation of the outdoors, creativity, and pride in themselves and their skills. To make Camp Norwich accessible to all families, the YMCA will adjust fees according to income. Located 20 minutes from the YMCA building, the facility encompasses 137 acres of lake, woods, and fields. Kids from kindergarten through 8th grade participate in one- or two-week sessions from late June through late August. In 2012, total enrollment for all camp weeks was 1261. Activities include swim lessons, canoeing and kayaking, archery, fishing, team sports, arts and crafts, drama, and overnight campouts for older kids. Norwich also provides a Counselor in Training (CIT) program for youth entering grades 9 and 10, which helps them build excellent leadership skills. For parents, Norwich is a worry-free form of childcare. Our instructors are carefully hired and trained, camp lasts from 9:00 a.m. until 4:30 each weekday, and the YMCA provides transportation from the main building and various locations around Northampton and Easthampton.




