Our responsibility is to support an old church (Christi Church Langwood, also known as the Sears Chapel); an interdenominational congregation which has used the church rent-free for many years; and a family archive, library, and museum, including pictures of many of the people buried in five crypts.

During 2012 we organized a Cemetery Corporation to care for the crypts, and the IRS accredited it as a 501(c)(13) organization during the year.

It has undertaken, with the support of an Endowment, an extensive program of repair and reconstruction in several of the crypts.

The two corporations have separate boards, about half of whom overlap.

Our small museum belongs to several neighborhood historic associations.

Part III line 28 - A comprehensive report by the Westling Engineering firm advised us of cracks in the masonry of our 90-foot steeple, and rot and damage to a rose window; after competition we selected the Alpha Masonry Company of Brighton and Andover, Mass; the Veterans Scaffolding Company, and Premier Woodworkers. Their tentative repairs were largely paid for by the Endowment.
