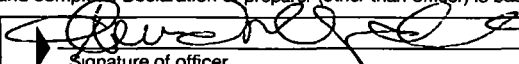

Beverly Youth Hockey operates a youth hockey program for children from ages 4-14. We provide an opportunity for the children of Beverly to participate in an organized hockey league. Approximately 150 youth participate annually.

Beverly Youth Hockey is a volunteer organization without any compensation to its officers, board of directors, or coaches.

Fundraising is on a volunteer basis consisting of cash calendars, player canning drives, a comedy night, and donations from the public.
