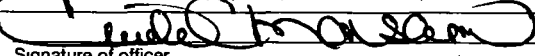

Public support and donations continued to be raised for earthquake relief in Haiti. Specifically to construct the Jacmel Children's Center which will serve as an orphanage for 100, and provide food, shelter, clothing, and educational services to local children by the hundreds.

The JCC construction is approximately 70% complete and we expect the center to be occupied by the end of 2013.

As well, support for the ACFFC, an Art School, was established to teach the area's children a sustainable craft, community involvement and social responsibility continues. A team volunteers again traveled to Jacmel, Haiti at their own expense to volunteer at the organizations.

The volunteers participated in manual labor construction, painting, clean-up. As well, they tutored English, assisted with community art projects and provided some objective hope to the children that their country and communities were being rebuilt.

These activities fall within our exempt purpose of "provide charitable services both nationally and internationally where need arises; and make grants or otherwise distribute funds to organizations..."

Promotional and educational awareness events were held to bring public awareness to our organization and the specific exempt purpose and mission of initiating and administering charitable acts of kindness on a local level around the globe. Proposed acts that met our program criteria and budgetary limitations were funded. Participants shared their charitable acts with others through use of creative video and pictorial art work. Small retreats and productions were held which provided local communities with writing workshops, cross cultural activities, exploration and learning. As well educational and creative storytelling and artistically present movement productions were offered.
