While in South Africa, we used our film during multiple trainings we led: for 4th year medical students at the University of Cape Town, pediatric grand rounds at Stellenbosch University/Tygerberg Children's Hospital, and a perinatal bereavement workshop hosted by Mowbray Maternity Hospital. Additionally, we provided two educational sessions at the End-of-Life Nursing Education Consortium (ELNEC) for the Duke Pediatric Quality of Life Program in Durham, NC (April and October 2012).
