1. Summary of Significant Accounting Policies

Organization and Nature of Activities

Eagle-Tribune Santa Claus Trust (the Organization), is a not-for-profit organization which accepts donations from the general public and distributes them to certain qualified charitable organizations in Massachusetts.

Basis of Accounting

The financial statements of the Organization have been prepared on the accrual basis of accounting and, accordingly, reflect all significant receivables, payables and other liabilities. The statement of activities does not purport to present the results of operations or the net income or loss for the period as would a statement of income for a commercial enterprise.

Management Estimates and Assumptions

The Organization has used estimates and assumptions relating to the reporting of assets and liabilities and the disclosure of contingent assets and liabilities in its preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America. Actual results experienced by the Organization may differ from those estimates.

Financial Statement Presentation

In accordance with accounting and reporting standards for not-for-profit organizations, the Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

Contributions

Contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted support depending on the existence or nature of any donor restrictions.

Donor restricted contributions whose restrictions are met within the same fiscal year are reported as unrestricted support.

Contributed Services

The Organization receives a substantial amount of services donated by Eagle-Tribune Publishing Company in order to carry out fundraising activities. These donated services have not been recognized in the statement of activities because the criteria for recognition under generally accepted accounting principles has not been satisfied.

Cash and Cash Equivalents

The Organization has cash and cash equivalent balances at one financial institution located in Massachusetts. At times such balances may exceed federally insured limits. The Organization monitors regularly the financial condition of the financial institution, along with its cash balances, in an attempt to minimize this potential risk. The Organization considers all highly liquid money market accounts with an original maturity of three months or less to be cash equivalents.

Donations Payable

Donations payable consist of amounts awarded, but not paid, to local qualified charitable organizations. All amounts awarded are to be paid during the year ending December 31, 2013.

Advertising Costs

Advertising costs are expensed as incurred. For the year ended December 31, 2012, advertising costs amounted to \$1,890.

Income Taxes

The Organization is a not-for-profit organization as described in Section 501(c)(3) of the Internal Revenue Code and is exempt from federal and state income taxes.

The Organization files federal and state tax returns where statutes of limitations generally range from three to five years, and is not currently subject to examination by any jurisdiction for any years.

Subsequent Events

The Organization evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 9, 2013, which is the date the financial statements were available to be issued.
