

(Revenue \$ 73,344.)LODGING PROGRAM: The Lodging Program provides safe and affordable temporary housing to men and women who fall within the mission guidelines. Seamen's also provides temporary emergency housing free of charge to individuals who fall within the mission and to members of the local community who find themselves in hardship. In 2012, Seamen's provided 385 room nights at reduced affordable rates to individuals who fell within the mission parameters who were visiting and working in the Newport area. Seamen's also provided 474 emergency room nights for free to individuals in need.**4c** (Code: ) (Expenses \$ 93,968. including grants of \$ 0.) (Revenue \$ 0.)HUMAN SERVICES: The Human Services Program provides assistance to those individuals who fall within the mission guidelines, as well as members of the local community who find themselves in hardship. In 2012, 671 free meals were provided to individuals in the Seamen's Cafe. Seamen's provides and delivers "Soup to the Docks" twice weekly to the Newport and Narragansett working docks. In 2012, this program delivered over 3,800 bowls of soup to local fishermen and dock workers. In 2012, Seamen's hosted three community meals serving over 650 individuals in need. Seamen's has also assisted over 280 families in need with gift cards for the purchase of food and personal items. In 2012, Seamen's assisted 58 individuals with funding for basic needs such as medications and clothing. Seamen's also provided rental assistance to 33 and heating assistance to
