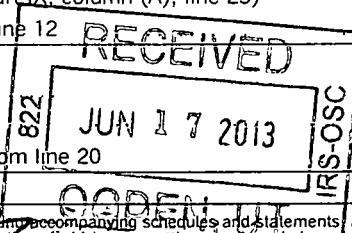

Building Operations at 115 East Main Road: FLCWC provides and maintains a facility on East Main Road in Little Compton for health and wellness practitioners who offer services and programs to the local community. In 2012 the center hosted an adult care service; pediatric, podiatric, and chiropractic clinics; and massage reflexology, and yoga therapy services. FLCWC built a food pantry on site that now hosts the Little Compton Food Bank.

4b (Code) (Expenses \$ 22,738. including grants of \$ 0.) (Revenue \$ 0.)

Program Management and Support: FLCWC provides administrative and marketing support to the practitioners in the facility. FLCWC also hosts health and community outreach programs and seminars. In 2012, FLCWC held seminars on a variety of topics including: healthy eating, Lyme disease, and Cancer nutrition.

Senior Transportation Study: FLCWC studies the transportation needs of seniors in Little Compton not served by any public transportation, initiates efforts to educate the community on transportation for medical appointments, and investigates a volunteer driver program.
