



It is reviewed and signed off by the chairperson of the Board of Directors. At the next scheduled business meeting, an announcement is made and written into the Minutes that Form 990 has been filed and is available in the club's office, upon request, for a review by a club's member in good standing.

Part VI line 19

All governing documents, policies and financial statements are available, during business hours, for review by members. All records are kept in the club's office and, upon a freedom of information request, are available for public viewing. Form 990 is filed with the IRS and, if requested, a copy is made available to the parent organization in Chicago, IL.

Part XII, line 2(c)

The Constitution and the By-Laws mandate annual election of a three member Board of Directors. The directors oversee that the club is managed properly and honestly. The members meet quarterly to examine the financial health of the club and the operations and subsequently issue a report. They are represented at Executive Board meetings and discuss all financial and economic matters relating to the club. They arrange meetings between themselves or together with the officers to assess and evaluate the financial and material aspects the club. The chairperson has the right to demand information for himself and the directors. The right encompasses all matters concerning club's operations. They also have the authority to request and demand an independent audit, if deemed necessary.
