SCIENCE PARK DEVELOPMENT CORPORATION (SPDC) WAS ESTABLISHED IN AUGUST OF 1981 AS A PART OF A COOPERATIVE EFFORT BY THE CITY OF NEW HAVEN, CONNECTICUT, YALE UNIVERSITY, AND OLIN CORPORATION TO MOBILIZE THEIR CONSIDERABLE RESOURCES TO CREATE A NEW ECONOMIC BASE AT THE SITE OF A MULTI-TRACT, PREDOMINATELY VACANT, INDUSTRIAL COMPLEX ADJACENT TO THE YALE SCIENCE HILL CAMPUS AND IN NEW HAVEN'S STATE-DESIGNATED ENTERPRISE ZONE. IT'S GOAL IS TO FURTHER THE REVITALIZATION OF THE CITY OF NEW HAVEN THROUGH THE DEVELOPMENT AND ENHANCEMENT OF EMPLOYMENT OPPORTUNITIES FOR AREA RESIDENTS, RELIEF OF POVERTY AND NEIGHBORHOOD TENSION, AND THE PREVENTION OF BLIGHT AND DETERIORATION IN THE SURROUNDING DIXWELL-NEWHALLVILLE NEIGHBORHOOD AREAS. THE PARK ATTRACTS START-UP AND HIGH TECHNOLOGY FIRMS, INCLUDING LIFE SCIENCE AND LIGHT MANUFACTURING AND ASSEMBLY INDUSTRIES. AS A HOME BASE FOR THESE COMPANIES, SPDC PROVIDES ECONOMIC BENEFITS TO THE CITY OF NEW HAVEN AS A WHOLE, AND OFFERS INDIRECT EMPLOYMENT OPPORTUNITIES TO AREA RESIDENTS. THE SCIENCE PARK PLANNED DEVELOPMENT DISTRICT EMPLOYMENT SURVEY TALLIED APPROXIMATELY 37 COMPANIES, FROM EXPANDING START-UP VENTURES TO MATURE ENTERPRISES AND DIVISIONS OF MULTINATIONAL CORPORATIONS. THESE ENTITIES EMPLOY OVER 1,200 PEOPLE IN THE PARK. TENANT COMPANIES AT SCIENCE PARK ARE PART OF A DYNAMIC R&D COMMUNITY AND CAMPUS-LIKE ENVIRONMENT. THESE COMPANIES BENEFIT BY ASSOCIATION AND USE OF FACILITIES WITH NEARBY YALE UNIVERSITY. IN JULY OF 1998, THE CONNECTICUT HOUSING FINANCE AUTHORITY (CHFA) COMMITTED \$14 MILLION TO DEMOLISH OBSOLETE STRUCTURES, AND TO REHABILITATE AND/OR CONSTRUCT NEW BUILDINGS IN THE PARK. YALE UNIVERSITY PROVIDED SUPPORTING FUNDS DURING CONSTRUCTION ACTIVITIES, OLIN CORPORATION APPROVED DONATION OF ADDITIONAL LAND AND FACILITIES, AND THE CITY OF NEW HAVEN PROVIDED CONTRIBUTIONS IN THE FORM OF CAPITAL IMPROVEMENTS. THESE WERE IN ADDITION TO CONNECTICUT DEVELOPMENT AUTHORITY (CDA) AND DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT (DECD) PREVIOUS COMMITMENTS TO THE PARK. THE MAJOR PORTION OF THE CHFA FUNDS WERE USED TO RENOVATE AND EXPAND A 102,000 SQUARE FOOT OFFICE/LAB BUILDING THAT IS NOW LEASED AND OCCUPIED, PRIMARILY TO COMPANIES IN THE BIOTECH FIELD. GROUND LEASE TRANSACTIONS IN 2000 AND SUBSEQUENTLY, BETWEEN SPDC AND A FORMER DEVELOPER RESULTED IN THE INFILL AND RENOVATION OF A 267,000 SQ. FT. OFFICE/LAB BUILDING, RENOVATION OF PARKING LOTS ENCOMPASSING APPROXIMATELY 250 PARKING SPACES, AND DEMOLITION OF FIVE ABANDONED AND DERELICT BUILDINGS BEGINNING IN 2007, ANOTHER DEVELOPER ASSUMED THREE GROUND LEASES UNDER THESE AND SUBSEQUENT LEASES, ADDITIONAL ABANDONED BUILDINGS WERE DEMOLISHED, A STRUCTURED PARKING GARAGE FOR OVER ONE THOUSAND VEHICLES WAS COMPLETED IN 2009, A VACANT FACTORY WAS RENOVATED FOR OFFICE AND TECHNOLOGY TENANTS AND IS NOW OVER 60% OCCUPIED, AND A CHILLED WATER FACILITY SHELL WAS COMPLETED IN 2011. IN 2007, SPDC ISSUED AN RFQ FOR DEVELOPMENT OF A SEVEN ACRE ABANDONED, DERELICT, MULTI-BUILDING TRACT IN SCIENCE PARK. IN 2011, A COMMERCIAL GROUND LEASE ENCOMPASSING PART OF THIS TRACT RESULTED IN ONE OF THE FASTEST GROWING COMPANIES IN THE COUNTRY BUILDING AND/OR RENOVATING THREE BUILDINGS. PERIPHERAL AGREEMENTS ENCOMPASS TWO ADDITIONAL SPDC TRACTS. A REDEVELOPMENT AGREEMENT, WITH A JOINT VENTURE COMPRISED OF NATIONAL AND REGIONAL DEVELOPERS, WAS ALSO EXECUTED IN 2011 AND WILL PROVIDE RESIDENTIAL HOUSING AND SHARED PARKING ON TWO OF THE PARCELS. THIS PROJECT IS ANTICIPATED TO BREAK GROUND IN SPRING 2013. SCIENCE PARK IS, AND WILL CONTINUE TO BE, A VIBRANT, INTEGRAL PART OF SURROUNDING NEIGHBORHOODS, NEW HAVEN, AND CONNECTICUT AS A WHOLE.
