Relevance is not affiliated with any one denomination, but its mission is to work with all evangelical churches.

Relevance provides discipleship and service opportunities in the Corvallis area by offering space to other Christian organizations and for concerts, movies, and events. A Fellowship & Coffee group utilized the facilities each week of the school year. Young Life and their leaders utilized the facility throughout the year for club meetings. Friends of Internationals utilized the facility for their Spring Break launch. Campus ministries utilized the facility to reach out to those living at OSU and going to school at LBCC. Informal Bible Studies and study groups met at the Courtyard through the year. Attendance to these gathering during the school year exceeded 3000 people.

4b (Code: \_\_\_\_\_) (Expenses \$ 253441 including grants of \$ \_\_\_\_\_) (Revenue \$ 289711)  
Relevance owns and operates the Courtyard in Corvallis, OR, near Oregon State University. The purpose of the Courtyard is to provide an encouraging and economical living situation where up to 48 Christian collegiate men and women can be built up in their relationship with Jesus Christ and with one another. Toward this end, the Courtyard works at establishing an atmosphere of Christian fellowship and spiritual growth so that the scholastic, intellectual, cultural, social and athletic aspects of living may be pursued in ways honoring to the Lord. Courtyard residents are expected to participate in community service each school term, be in community with each others in solid Biblical teaching and worship, attend gender specific small accountability groups, and walk in a manner that is modeled by Christ and the entire Word of God. Fall term 2012, there was over 900 hours of community service done. The facility is run in a co-op manner with residents being guided by a full-time paid director, chef and a 3/4 time director, each resident participates with acts of service (ministry) of chores that need to be accomplished for the benefit of all. The full-time chef provides meals for the residents during weekdays and for different events.

Although not associated with any one denomination, its mission is to work in collaboration with all churches to reach people for Jesus Christ. The Courtyard is a means to achieve that vision in two specific ways. (A) through providing and environment for Christian students to sharpen their spiritual persons through discipleship and serving in the community and (B) by providing public teaching and activities that welcome the community in to see the relevance of Jesus Christ through courses. The Courtyard also offers other events that reach out to the community in the form of movies, concerts, and activities. A church plant, Servant's Fellowship Evangelical-Free Church used the space for their Sunday morning services. A church plant, The Hive used the space for their Saturday evening services.

Schedule L Part II A 20,000 sq. ft. building (Courtyard) was purchased through a seller (Ayres) mortgage contract of \$600,000 @ 7%, donations and a \$400,000 line of credit @ 6% by Walter & Kimberly Griffiths (Board Members) in 2007

The credit line was in written form and approved by the Board of Directors. The building was purchased, renovated, and furnished. Extensive repairs and maintenance have been done to the long vacant building to bring it to standards.

As of 12/31/08, the line of credit was \$392,285 including interest. During 2008, \$7,000 was additionally drawn on the line

During 2009, over 75 windows were replaced and utilized the Energy Trust of Oregon rebates to upgrade to all double-pane windows for energy efficiency. The two boilers had an extensive tune-up to be as energy efficient as possible.

As of 12/31/10, the line of credit had been reduced to \$380,713. During 2010, continued maintenance and equipment purchases were made including replacement of a 85 gallon hot water heater to a energy efficient hybrid on-demand unit. A new gas-fired

convection oven was installed along with energy efficient exit signs, all using available Energy Trust of Oregon rebates.

The line of credit continued to decrease; as of 12/31/11 the balance was \$376,938. The organization refinanced the mortgage and line of credit into a single mortgage loan with OSU Federal Credit Union as of 9/20/12 and the line of credit was retired on 10/16/12.

As of 12/31/12, the mortgage balance with OSU Federal Credit Union was \$901997.
