South Boston Community Development Foundation, Inc.'s (SBCDF) is a non profit corporation incorporated whose primary activity is making grants to local South Boston charitable, section 501 (c)(3) organizations which promote and encourage the improvement of the quality of life in the South Boston community. These grants are funded by receipts from sponsor events which are held at the Boston Convention and Exhibition Center and is operated by the Massachusetts Convention Center Authority. This funding arrangement was mandated by the Massachusetts Legislature (Chapter 152 of the Acts of 1997).

Summary of Significant Accounting Policies:

A. The Foundation's policy is to prepare its financial statements on the accrued basis of accounting. The significant accounting policies followed are described below to enhance the usefulness of the financial statements to the reader.

B. All Grants of the Foundation are from

The Grants receivable, if any, are for events already held by the Center and by law such funds must be forwarded to SBCDF. All grants are considered unrestricted as the Board, after expenses, can donate the funds to any non profit organization in South Boston.

C. Members of the Foundation volunteer their time without payment, to the administration and other activities. Time records for volunteers are not maintained and the value of their services has not been determined. No amounts have been recognized in the statement of activities because the criteria for recognition under SFAS No.116 has not been satisfied.

D. The preparation of financial statements in conformity with the generally accepted accounting principles requires the use of management's estimates and assumptions that effect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
