THE FUNDS ARE EXCLUSIVELY FOR THE PURCHASE OF ART TO ENRICH THE PERMANENT COLLECTION OF THE MUSEUM AND ANY ARTWORK PURCHASED WITH THESE FUNDS WOULD BELONG TO THE TOWN. THE AMOUNT OF FUNDS RECEIVED FROM THE SALE OF ARTIFACTS DURING 2012 WAS \$730,372, WHICH ARE REFLECTED AS FUNDS HELD IN CUSTODY ON THE STATEMENTS OF FINANCIAL POSITION.
