Since 2005, the Foundation's mission has been successfully accomplished through the increase in scope of its collections from \$ 1.2 mm of value at the end of 2005 to \$15.75 mm at the end of 2011 This increase was largely achieved through major gifts of art such as Jean Prouv's Tropical House, Chuck Close's Ame, Hannah Wilke's S O S Starification Object Series, Robert Gober's untitled sculpture, David Smith's untitled works on paper, Richard Avedon photos and this year's pledge of a significant number of works as described in Schedule B The Foundation's collection is on long term loan to the Centre Pompidou
