**NOTE 1: ORGANIZATION**

The Riverbay Fund, Inc. (the "Fund"), a not-for-profit organization, was organized under the New York Not-for-Profit Corporation law. The purpose of the Fund is to promote recreational and cultural activities for the youth, senior citizens and other residents of ("Co-op City"), located in the Bronx, New York.

Revenues to pay for the Fund's activities are generated primarily from donations and fees charged at Fund-sponsored performances and events (ticket sales). Other revenues are received from membership dues, governmental cultural grants, and sales of refreshments at events.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The Fund reports information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. The Fund has no temporarily or permanently restricted net assets at December 31, 2012.

**Cash and Concentrations of Credit Risk**

Financial instruments that potentially subject the Fund to concentrations of credit risk consist of cash in financial institutions. At December 31, 2012, substantially all of the Fund's cash was in one bank and subject to FDIC's limit of \$250,000 per depositor per insured bank. Under the Dodd-Frank Act, beginning December 31, 2010 through December 31, 2012, all noninterest-bearing transaction accounts were fully insured, regardless of the balances of the account and the ownership capacity of the fund.

**Use of Estimates**

The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Fixed Assets**

Fixed assets are comprised of equipment, which are capitalized at cost and depreciated over their estimated useful lives (generally five years) on a straight-line basis.

**Accounting for Uncertainty in Income Taxes**

The Fund recognizes the effect of income tax positions only when they are more likely than not of being sustained. Management has determined that the Fund had no uncertain tax positions that would require financial statement recognition or disclosure. The Fund is no longer subject to audits by the applicable taxing jurisdictions for periods prior to December 31, 2009.

**Subsequent Events**

Management has evaluated, for potential recognition and disclosure, events subsequent to the date of the statement of financial position through August 8, 2013, the date the financial statements were available to be issued.

**NOTE 3: RELATED PARTY TRANSACTIONS, DONATED SERVICES AND FACILITIES**

Riverbay Corporation is an affiliated entity of the Fund and is a limited profit housing company, which was organized under the Private Housing Finance Law of the State of New York for the purpose of owning, maintaining and operating the low and middle-income cooperative housing development known as Co-op City. The Fund has the same Board of Directors and officers as Riverbay Corporation and receives a significant amount of administration support and use of facilities from the Riverbay Corporation. However, since no objective basis exists for recording and assigning value to these services, they are not reflected in the accompanying financial statements.

The Fund's insurance coverage is provided under Riverbay Corporation, Inc.'s policy. The portion of the Fund's premiums for 2012 and 2011 were \$1,225 and \$1,839, respectively.

On August 1, 2010, the Fund was awarded a \$1,000,000 grant from New York State Energy Research and Development Authority ("NYSERDA"), to be used for an energy efficient lighting program in the garages owned by Riverbay Corporation. In connection with the NYSERDA grant, the Fund entered a lease agreement as tenant with the Riverbay Corporation. The lease provides the Fund to possess, use, and access the roofs, exterior walls, power systems, utility risers, electrical and lighting fixtures and related fixtures and improvements of the Riverbay Corporation's eight garages. The lease provides for an annual rent of \$100,000 and expires on July 31, 2020. As of December 31, 2012, Riverbay Corporation made an in-kind contribution in the amount of \$100,000 in lieu of collecting rent owed by the Fund. Such amount is reflected as an in-kind contribution in the accompanying financial statements.

The Fund qualifies as a publicly supported organization of the type described in Section 501(c)(3) of the Internal Revenue Code and is exempt from Federal income taxes. The Fund is also exempt from New York State and New York City income and sales taxes.
