See Schedule OFund for the Aged, Inc. places emphasis on creating meaningful philanthropic partnerships with individual donors, foundations, corporations, and agencies. Numerous major gifts and grants are received for a wide array of programs including but not limited to the geriatric career development program, telemedicine, palliative care, research, volunteer support, intergenerational youth programs, computer training for elders, dining assistance, religious programming as well as Jewish community outreach and programming. Additionally, Fund for the Aged oversees Jewish Homes Capital Campaign. In 2012, Jewish Home raised more than \$15 million for capital projects in New York City and Westchester bringing the total raised toward capital campaign initiatives to \$87 million. Gifts were made to the Living Center of Manhattan and Sarah Neuman Center renovations and Green House Projects. Through our annual campaign, \$3.25 million was raised to fund quality of life programming for the elders. Jewish Home services and workforce development programs for staff. The 2012 Annual Campaign inspired high participation rates among management level staff.
