2012 Program and Grant Partner Accomplishment Narrative Overview Third Waves programs have been scaled down this year to grantmaking. Our grants were all general operating and technical assistance grants made on a renewal basis. Despite major budget cuts, we were able to make 12 grants totaling \$150,000, of which \$22,000 went out as technical assistance funds to five organizations. We maintained a strong partnership with the Catalyst fund, which accounts for \$100,000 of our total grant dollars. Catalyst grants focus on policy-focused, reproductive justice work that is led by women of color. Third Waves 2012 Catalyst grantees are New Voices Pittsburgh, SPARK Reproductive Justice NOW, Young Women of Color HIV/AIDS Coalition, Choice USA, FIERCE, and the Sylvia Rivera Law Project. This year's scaled-down program budget does not allow for any capacity building support outside of the technical assistance grants. The \$22,000 in technical assistance was distributed to organizations that identified a major organizational development need, showcased the capacity to utilize and track their progress, and/or were in the process of an executive transition. This year's recipients of technical assistance grants include New Voices Pittsburgh, SPARK Reproductive Justice NOW, Young Women of Color HIV/AIDS Coalition, Khmer Girls in Action, and Justice Now. Grant Partner Highlights SPARK Reproductive Justice NOW recently hired a new Executive Director, Malika Redmond. After an extensive conversation with Malika about her new role, seeing her present at the Funders Network, and having had a chance to read up on the amazing work she has accomplished starting at the age of 14, it seems that she is a wonderful pick for SPARK and that the hire is a cause for celebration. This year is intended to be the final year of grants we make to SPARK after having supported their growth for six consecutive years. This hire is a wonderful sign of stability and potential for growth for the organization, and we should be publicly celebrating their success as an organization in any materials we might put together about our impact over the years! We should be on the lookout for some new staff hires that will be made in the near future that will likely ramp up their local organizing power, and jumpstart their regional growth. Choice USA recently launched a blog series on Queering Reproductive Justice. This campaign is occurring in June, LGBT Pride Month, and is in recognition that 40% of their base identified as LGBTQ, and that Reproductive Justice issues are Queer issues and visa-versa. This new campaign hits on two major priorities within our grantmaking: that our grantee organizations reflect the needs and identities of their constituents, and that they take on campaigns around the intersections of oppression. This campaign is important coming from Choice USA due to their large online reach, and because their campaigns tend to not be particularly intersectional. This June, Branching Seedz of Resistance, a project of the Colorado Anti-Violence Project, put on their annual Colorado Queer Youth Summit for youth ages 12-24, and this year they incorporated their first ever Colorado Queer Youth Leadership Retreat! The retreat gives queer youth a full weekend to gain and practice leadership and networking skills while building community and fighting for liberation. The gathering is both a space for youth to gain new leadership tools and as a space to strengthen statewide collaboration and movement building. As a result of Sylvia Rivera Law Project's expansion into advocacy and movement building, SRLP successfully pushed the Department of Justice to include meaningful protections for incarcerated transgender, gender non-conforming and intersex (TGNCI) people within the final rule implementing the Prison Rape Elimination Act Technical Assistance Work Plans. In light of SPARK's executive director transition, SPARK is using their technical assistance grant to hire an experienced transition consultant with connections to RH/RJ funders, leaders, and organizations to support the staff during transition, work with consultants on intensive leadership support and transition with existing ED to current ED, and funding for a transition retreat with board and staff and consultants. New Voices is using their technical assistance grant to hire an organizational development consultant to produce an operational transition plan for the next two years. New Voices is also working to establish a 501(c4) structure called New Voices Pennsylvania. This entity will allow them to conduct Reproductive Justice work in an overtly political way to influence statewide culture, policy and political change. Funding will be used to apply for a 501(c4) status, and to pay a nonprofit management center for their support in the process. Khmer Girls in Action (KGA) plans to use their technical assistance grant to finalize their fiscal policy. KGA Executive Director and Board of Directors have produced a draft with the support of consultant Carol Cantwell. In addition to their fiscal policies, they will update and finalize their internal administrative/fiscal forms (i.e. reimbursement, mileage, invoices, and contracts). Secondly, KGA wants to develop a formal board recruitment process. Some of their funding will also be used to fund their board/staff retreat. Young Women of Color HIV/AIDS Coalition (YWCHAC) plans to use their technical assistance grant to work with an organization called SEED to conduct a five-year strategic plan. Over the length of a year, YWCHAC will develop a plan that includes benchmarks for improving internal communication systems, developing tools to capture leadership development outcomes, and engaging more voices to expand and carry the vision. Justice Now will use the technical assistance grant to re-launch their website. Their website layout is designed and somewhat finished but their staff do not have the training they need to maintain it. They will hire a web designer to work with their founding director, Cynthia Chandler, to improve the website and give staff the appropriate level of training they will need to maintain the website in-house. Conclusion Third Waves grantees are moving in the direction of Third Waves Gender Justice vision on their own accord, a good sign that Third Wave is on the right track with this shift to our funding streams. We still have not released the Gender Justice Report which would be a great compliment to these shifts, but given capacity issues, it is unclear if now would be the right time. There is quite a bit of interest in exploring Gender Justice within the funder networks we are a part of, and the conversations about the RJ and LGBTQ intersections is growing in number both in the field and within philanthropy, and at the same time there is a definite leadership void without Third Wave taking the work on. Third Waves grant partners are very interested in playing a role in the next phase of Third Wave and are eager to show their support either through fundraising efforts, or through documenting the impact that we have had on their organizations over the years. And lastly, we are at the mid-point in the 2012 grant cycle, which is typically the time that mid-way check-in calls would be used to capture progress on grant partner activities for the year. Without these calls, it is challenging to project next year's grants, and it is difficult to write grant reports that need to be submitted before the end of year grantee reports start coming in. In order to avoid an end of year crunch, it might make sense to begin the process of collecting data on the use of the grant funds thus far, and sooner rather than later.
