Do Something, Inc. (the organization) is a not-for-profit organization founded in 1993 to advocate and promote youth social leadership, community activism and citizenship. Today it is also known as DoSomething.org, and is one of the largest organizations in the United States that helps young people rock causes they care about. A driving force in creating a culture of volunteerism, DoSomething.org is on track to activate 5 million members by 2015. By leveraging the web, television, mobile and pop culture, DoSomething.org inspires, empowers and celebrates a generation of doers: teenagers who recognize the need to do something, believe in their ability to get it done, and then take action. The services are largely directed to young people (ages 13-25) who want to make a difference, but need help actively participating and leading in community change efforts. The call to action is always something that has a real impact and doesn't require money, an adult, or a car.

	DoSomething.org had another very successful year in 2012. We continued our focus on campaigns and further refined our focus on mobile acquisition and data. We beat our goal of 500,000 mobile members and got 1,110,000 instead and beat our overall goal of 1.4 million members. We were widely recognized as one of the Best Places to Work, including Best Nonprofits to Work for and Crains 15th Best Place to Work in NYC. In 2012, we saw our campaign numbers grow by 837% over 2011. Some of the highlights include: Our annual Teens for Jeans drive that empowered hundreds of thousands of teens to collect gently worn jeans and donate them, collecting over 1 million pairs of jeans for homeless children in need; Our Thumb Wars campaign that fought texting and driving in a fun, cheeky and impactful way and saw 179,000 teens participate; A new campaign model mobile gaming was born with our Pregnancy Text. We delivered over 100,000 text babies to teens nationwide so they could spread the word about teen pregnancy to their friends and family; Pics for Pets, a new Facebook app that deployed teens to animal shelters nationwide to take adorable pictures of the cats and dogs there, and then share them on their social networks in an effort to get them adopted; Grandparents Gone Wired, a second year campaign, where over 75,000 young people signed up to help their grandparents, and other seniors in their neighborhood, become tech-savvy in their use of email, Facebook and Skype; Our Vote Up or Shut Up campaign (nominated for a Webby) helped young people find their VSpot (or voting location) via text, and was celebrated by ringing the opening bell of the NASDAQ on election day. Other notable programs and accomplishments in 2012 include our Do Something Awards, hosted by the three guys from New Girl and airing in primetime on VH1 during the month of August. We revamped our website, which re-launched in spring 2012, and is now up for three Webby Awards for Excellence in youth websites, Charity Websites, and CSR websites. We are excited to report that our data shows that we over-index for minority youth, with our members being 18.4% African-American, 13.6% Asian, 21.6% Latino, 2.9% Native Alaskan, 1.2% Pacific Islander, and 34.6% white.
