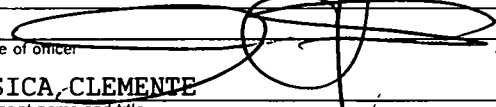
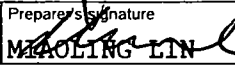

ON MARCH 18, 2011, THE ORGANIZATION THROUGH ITS OUTSIDE LEGAL COUNSEL, GOLDSTEIN HALL, PLLC, FILED FORMAL CHARGES AGAINST THE EXECUTIVE DIRECTOR WITH THE NYS OFFICE OF ATTORNEY GENERAL-CHARITIES BUREAU AND REQUESTED AN INVESTIGATION BY THE NEW YORK STATE OFFICE OF ATTORNEY GENERAL INTO ALLEGED MISCONDUCT, MALFEASANCE, IMPROPRIETIES, DEFALCATION AND MISAPPROPRIATION OF THE ORGANIZATION'S INCOME AND ASSETS. AS A RESULT OF THIS EVENT, THE FEDERAL TAX RETURNS AND FILINGS WITH THE NYSOAG OFFICE HAVE BEEN DELAYED, BECAUSE THE ORGANIZATION THROUGH ITS OUTSIDE COUNSEL AND AN INDEPENDENT FINANCIAL CONSULTANT UNDERTOOK AN INTERNAL INVESTIGATION, IN WHICH IT ALSO BELIEVED THAT THE PREDECESSOR INTERNAL ACCOUNTANT ALSO ACTED AS OUTSIDE AUDITOR IN VIOLATION OF THE INDEPENDENCE RULES AND ETHICS GUIDELINES PRESCRIBED BY THE AMERICAN INSTITUTE OF CPAS. IN 2013, THE BOARD OF DIRECTORS ENGAGED AN INDEPENDENT CPA FIRM TO ASSIST IT WITH THE PREPARATION OF ITS 2012 TAX RETURN AND THE AUDIT OF ITS FINANCIAL STATEMENTS.

DUE TO THE PENDING COMPLAINT AND INVESTIGATION OF THE FORMER DIRECTOR AND THE RESULTING REPLACEMENT OF OFFICERS AND DIRECTORS AT THE ORGANIZATION, CORPORATE FORMALITIES WERE NOT CONSISTENTLY ADHERED TO DURING THIS TIME PERIOD. THESE EVENTS ALSO DISRUPTED THE DAY TO DAY OPERATIONS OF THE ORGANIZATION, CAUSED CHANGES IN PERSONNEL AND DELAYED THE PRODUCTION OF TIMELY BOOKS AND RECORDS. JOSEPH INGENITO, THE FORMER CHIEF FINANCIAL OFFICER OF NOS QUEDAMOS, WAS ALSO CHARGED AT THE ARRAIGNMENT WITH FALSIFYING BUSINESS RECORDS.
