In 2012, Room to Grow served approximately 550 families and 600 children. These families visited the sites every three months for a total of approximately 1,800 visits, and received parenting information and support. Many children graduated from the program during this time and approximately 200 new babies were enrolled. The organization distributed 120,000 new and nearly-new baby items, including developmentally-appropriate toys, books, clothing and equipment. Room to Grow engaged more than 2,000 volunteers who performed a total of approximately 8,500 hours of work to sort, clean, fold, and display donated items and assist with other organizational efforts.
