The mission of the Park Avenue Armory is to develop and produce non-traditional works and untraditional arts programming in the performing and visual arts that require the freedom of unconventional spaces for their full realization With its palatial period rooms by leading Gilded Age designers and its soaring 55,000 square-foot Drill Hall, the Armory allows artists to create, and audiences to experience epic, immersive and adventurous work that cannot be done elsewhere in New York With its palace-like interiors, the Armory is also a magical setting for arts education for underserved public school children, with an emphasis on how to think outside the box

The Armory's second full season of cultural programming was curated by Consulting Artistic Director Kristy Edmunds and created new opportunities for artists to realize their most expansive and free-wheeling dreams The season featured commissions of monumental, immersive installations by visual artists Tom Sachs and Ann Hamilton and sound artists Janet Cardiff and George Bures Miller, epic music experiences provided by the New York Philharmonic and the Tune-In Festival, a re-staging of an historic dance piece by legendary modern dance choreographer Trisha Brown, and "Under Construction," a series of salon-style evenings presenting works in progress in the Armory's historic period rooms The season featured a spectacular series of productions that broke Armory box office records every performing arts production was sold out Over 110,000 visitors attended the Armory's 2012 events, which were also widely acclaimed by critics Tune-In Music Festival The 2012 Tune In Music Festival celebrated the 75th birthday of prolific pianist/composer Philip Glass, who served as curator and special guest The festival consisted of five concerts in four days at the end of February The opening concert featured the world premiere of a collaborative interpretation of "Kaddish", Allen Ginsberg's emotional and stirring poem mourning the loss of his mother and his thoughts on death, considered one of his finest works With a new score by Bill Frisell, commissioned by the Armory and performed by an eight-piece ensemble, the poem was read by Hal Willner and Chloe Webb in front of projected visuals by artist Ralph Steadman The festival's other presentations were "The Poet Speaks" with rock musician/poet Patti Smith and Philip Glass celebrating their favorite poets, "Music in Twelve Parts" performed by The Philip Glass Ensemble, an Afternoon Concert with Nico Muhly, Vijay Iyer, Tania Len, Zack Glass, Ashley MacIsaac and others, and "Another Look at Harmony", a choral work by Glass conducted by James Bagwell and performed by the Brooklyn Youth Chorus, the Collegiate Chorale, and organist Michael Riesman Every concert was sold out, and over 4,200 people attended Tom Sachs' installation "SPACE PROGRAM MARS" From May 16 through June 17, the Armory partnered with Creative Time to present an installation by visual artist Tom Sachs entitled "SPACE PROGRAM MARS" The installation manifested as a four-week mission to Mars, recasting the Drill Hall as an immersive space odyssey with dynamic and meticulously crafted sculptures Using his signature bricolage technique and simple materials that comprise the daily surrounds of his New York studio, Sachs engineered the component parts of the mission exploratory vehicles, mission control, launch platforms, suiting stations, special effects, recreational amenities, and Mars landscape, exposing both the process of their making and the complexities of the culture they reference Sachs and his studio team of thirteen "grumms" manned the installation, regularly demonstrating the myriad procedures, rituals, and tasks of their mission to Mars, demonstrating all that would be necessary for survival, scientific exploration and colonization of the extraterrestrial from food delivery systems to entertainment to agriculture The team "lifted off" to Mars several times throughout their residency, with real-time demonstrations playing out various narratives from take-off to landing The Financial Times called it a "wacky and intoxicating art immersion experiment " SPACE PROGRAM MARS addressed serious and profound issues in a playful way, exploring the commodification of abstract concepts such as originality, shock, newness, and mystery, expressing them in the personal and physical terms of production and process With a shift towards privatized space travel, "SPACE PROGRAM MARS" provoked reflection on the haves and have-nots, utopian follies and dystopian realities, asking barbed questions of modern creativity as related to conception, production, consumption, and circulation New York Philharmonic For two nights in late June, the Armory teamed up with the New York Philharmonic to co-produce two highly-anticipated concerts featuring spatial music in the Drill Hall The program was comprised of works that needed unconventional staging including Gabnelli's "Canzon XVI" with three brass ensembles, Boulez's "Rituel in memoriam Bruno Madern", the Act I Finale of Mozart's "Don Giovanni" featuring eight soloists and a chorus of 36, Stockhausen's rarely performed "Gruppen" for three orchestras and three conductors with the audience in the center, and Ives' haunting "The Unanswered Question" According to The New York Times, "Gruppen" was "both dissonant and beautiful" and "The Unanswered Question was" glowing, serene yet suspenseful " The production included 1,440 seats and 3 stages for the 3 orchestras that surrounded the audience, and seating that included balcony seats and yoga seats on the floor Both shows were completely sold out Trisha Brown Dance Company Legendary choreographer Trisha Brown brought her company to the Armory in a restaging of "Astral Converted", which was originally performed in 1991 with sets and costumes by Robert Rauschenberg and music by John Cage Ms Brown has a history of creating site-specific and large-scale work, the original performances of "Astral Converted" took place in Washington, D C with the audience sitting on the steps outside the National Gallery watching dancers set against the backdrop of the Washington Mall The choreographer's grounding in visual art and site-specific work made her an excellent candidate to take full advantage of the Armory's unconventional dance space and allowed the Armory to continue testing its space and learn how to present dance in its unusual setting "Astral Converted" was presented for the first time in 18 years in the soaring 55,000 square-foot Drill Hall for five performances in July A defining feature of the piece is a series of eight metal frame towers, created by Rauschenberg, which house the light and sound system for the performance Constructed from automotive parts-including car headlights-and powered by car batteries, the towers are activated by motion sensors which respond to the dancer's movements, thereby creating the performance's lighting and sound elements Rauschenberg's original towers, which range from two to eight feet in height, were restored for the Armory presentation The 55-minute work was performed by nine dancers in shiny silver and white unitards marked by reflector stripes that augment visibility in the piercing striated lighting of the headlights in Rauschenberg's set "Astral Converted" also featured John Cage's original music for the work Although it seems as if the relationship between the score and the choreography is incidental, it is, in fact, strongly correlated The piece worked beautifully in the Drill Hall, mimicking indoors both the intimacy and the vastness that audiences must have experienced during the original production Trisha Brown herself attended each performance and was thrilled Since Ms Brown will be retiring from choreography this year, it was a great honor to present her master work and reconstruct it for another generation of audiences to experience Janet Cardiff & George Bures Miller's The Murder of Crows From August 3 through September 9, the Drill Hall was filled with a 29-minute long sonic installation created by Canadian artists Janet Cardiff and George Bures Miller "The Murder of Crows"-the pair's largest sound installation to date-provided a compelling "sound play" that enveloped the audience in a visceral, sonic experience Both artists publicly acknowledged excitement at being able to bring "The Murder of Crows" to the Armory, citing its atmosphere as both "nostalgic" and "science fiction-like " Because the piece requires presentation in a large space, it can be presented only every few years, which also enables Cardiff and Miller to refresh the sounds for each new installation Moving and weaving approximately 800 individual sound tracks through 98 speakers mounted within the Drill Hall, the soundscape narrated a captivating and confounding melodrama, investigating concepts of desire, intimacy, love and loss The multifaceted soundscape used a fluttering of voices and sounds, from crashing waves to the hubbub of a factory floor, to transport the listener to an unexpected dream-like world A critic from The New York Times described the installation as "Beautifully realizedspooky and spectacular " "The Murder of Crows" was presented in association with the Mostly Mozart Festival Ann Hamilton, "the event of a thread" The year ended with a luminous, multisensory affair that drew together readings, sound, and live events within a field of swings that together invited visitors to connect to the action of each other and the work itself From December 7 to January 6, visitors were invit
