The World Congress is an annual event with the purpose of educating NGOs, providing a chance to network, and recognizing selected NGOs with an award. Unfortunately, in May this event had to be cancelled due to unrest in the country. In addition, we produced and distributed 10 NGO news and 4 Beyond Boundaries newsletters, and maintained the WANGO and ngohandbook.org websites. Mr. Taj Hamad represented WANGO at conferences and NGO meetings in Korea, Indonesia, Brazil, and Dubai.
