In 2012, the Mississippi Center for Justice had the following exempt purpose achievements - Under the terms of settlement of the BP oil disaster litigation, responsibility for the oil claims process transferred to the new Settlement Authority. On behalf of its Gulf Justice Consortium of legal aid providers, MCJ negotiated a new two-year contract to continue providing legal assistance to thousands of low-income victims of the oil disaster. The American Bar Association Section of Litigation recognized the significance and success of this innovative initiative with the award of its prestigious John Minor Wisdom Public Service and Professionalism Award - When funding from the National Foreclosure Settlement enabled the Mississippi Attorney General to create a foreclosure prevention initiative, he tapped MCJ to administer a three-year contract that enables the Center and the two federally funded legal aid programs to deploy six attorneys to provide foreclosure prevention assistance statewide. The two foreclosure lawyers for MCJ assisted hundreds of financially stressed Mississippians to mitigate the impact of the foreclosure crisis - With strong opposition voiced by MCJ and Mississippians for Fair Lending, proposed legislation to increase interest rates on small-dollar loans from 36 to 99 percent died in committee. The Center mobilized Mississippians for Fair Lending in support of a new initiative to provide workplace-based fair lending alternatives in partnership with mainstream financial institutions and including a financial education component. The Clinton Global Initiative America featured the MCJ innovative fair lending initiative at its annual conference in Chicago - Former Governor Ronnie Musgrove partnered with Center staff to offer three training events to 75 Mississippi lawyers to prepare them to represent children with special educational needs or disciplinary issues that threaten their opportunity to remain in school. Since the launch of a program to provide representation to individual families, the Center has received requests for service from 200 and has provided service to 150 families about 20 of these by pro bono lawyers and the remainder by MCJ staff - The staff community organizer at MCJ developed a nine-week curriculum to educate seniors in Greenville about how they can bring change in their cities. The graduating class of 19 continues to work with the Center on issues of concern to them, and the curriculum provided a template for subsequent use at a course in Jackson - The Center has become nationally and even internationally recognized for its disaster recovery expertise. A Center attorney was invited to Japan to offer counsel and policy advice in the wake of its recent, devastating tsunami, and a Japanese attorney in turn traveled to the Mississippi coast to get a more in-depth look at the MCJ model. When Superstorm Sandy struck New Jersey and New York, four Center lawyers traveled immediately to the area to assist local legal aid programs - The Center continued to vigilantly monitor Mississippi Development Authority implementation of the terms of the MCJ 2010 landmark settlement with the State of Mississippi and the U.S. Department of Housing and Urban Development and provided direct services to many of the approximately 4,500 households eligible for the new program of hurricane housing repair, including assistance with proof of income, intake issues, and clearing title. At year-end, it appeared likely that additional households found to be eligible would push the settlement value above the original estimate of \$132 million - The Center continued its advocacy for improved access to Medicaid and worked to ensure full and timely implementation of the Affordable Care Act in Mississippi. The Center took a lead role in mobilizing a new coalition, Mississippi Health Care Access, to persuade the Mississippi legislature to expand Medicaid as authorized by ACA, and released an issue brief documenting the benefits of adopting such a policy. Community organizing among youth and clergy in the Delta encompassed the use of town hall meetings and media outreach - The Center provided free legal services to people living with HIV/AIDS, focusing in particular on discrimination in employment, housing and access to medical care, and recruiting pro bono attorneys to represent a woman wrongfully turned away from a homeless shelter after she disclosed her HIV status - The Center represented several young African American women who had incurred significant student loan debt to take classes at Virginia College, a for-profit institution, only to discover that their degrees did not qualify them for employment. The federal court case alleges violations of the Equal Credit Opportunity Act and Title VI of the Civil Rights Act of 1964 and asserts claims of fraud, breach of contract and negligence.
