THE OPEN DOORS HOMELESS COALITION CONTINUUM OF CARE WILL DISTRIBUTE THE FUNDS, APPROXIMATELY \$2,900,000, THROUGH MEMBER AGENCIES AND THROUGH OTHER COAST AGENCIES IN HARRISON, HANCOCK, JACKSON, PEARL RIVER, STONE AND GEORGE COUNTIES THROUGH AN RFP PROCESS. THE FUNDS WILL ASSIST INDIVIDUALS AND FAMILIES TO QUICKLY FIND HOUSING AFTER DISPLACEMENT FOR FINANCIAL REASONS, LIKE JOB LOSS, OR WILL ASSIST PEOPLE IN STAYING IN HOMES THAT THEY WOULD LOSE IF THEY DID NOT RECEIVE ASSISTANCE. THE ASSISTANCE WILL INCLUDE RENTAL ASSISTANCE FOR 1-18 MONTHS AND CASE MANAGEMENT SERVICES AND BUDGET COUNSELING TO ENSURE LONG-TERM STABILITY AND SELF-SUFFICIENCY WHEN FINANCIAL ASSISTANCE ENDS. RESULTS WILL BE TRACKED THROUGH THE WELL-ESTABLISHED HOMELESS MANAGEMENT INFORMATION SYSTEM (HMIS), AS REQUIRED BY THE FEDERAL LEGISLATION. RESULTS WILL BE REPORTED QUARTERLY TO MDA WHO WILL REPORT TO HUD WHO WILL POST THE AGGREGATE STATE DATA ON THE U.S. RECOVERY GOV WEBSITE.
