FIFTH: The Corporation is a Type B corporation under Section 201 of the Not-for-Profit Corporation Law.



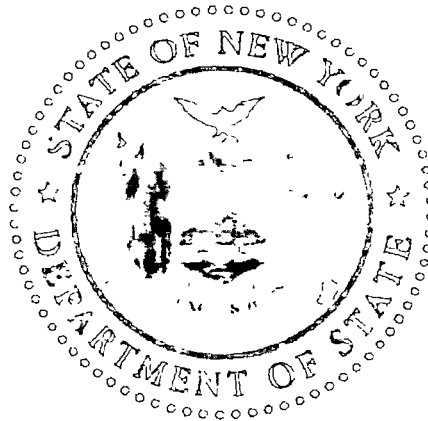
