### **CAFO Expansion Discussed at THIS Monday, January 16 Supervisors Meeting – January 13**

Dear JFAN Supporters,

JFAN has been closely monitoring Ryan Robertson's expansions at KK Finishers and Brighton Finishers in northern Jefferson County. This **Monday, January 16, the Jefferson County Board of Supervisors will be scoring the new Master Matrix for KK Finishers. The meeting begins at 9:00 am** and the scoring will be addressed early in the meeting.

At the December 22 public hearing, the supervisors did not recommend that the DNR approve the construction permit for KK Finishers as the Master Matrix did not meet the minimum 440 points out of 880. A new Master Matrix was submitted just hours before the public hearing, but without enough time for review, it was not considered at the public hearing. This is the Master Matrix that will now be scored on Monday.

The supervisors also still have to decide if they will hold another public hearing specifically on the KK Finishers site and will decide that on Monday morning as well. Therefore, **if they decide against a public hearing, the Monday supervisors meeting may be the only opportunity to make public comments on the Master Matrix for KK Finishers.**

JFAN will attend this meeting, and we encourage any others interested in making any public comments to attend as well.

The Master Matrix will be scored as one of the first meeting agenda items. At the conclusion of the entire meeting, the public will then have an opportunity to comment on the Master Matrix. If you will be attending and would like your comments forwarded to the DNR, we recommend you bring a written version of what you would like to say.

JFAN will continue to monitor these two expansions and provide updates as available.

### **Background Information on the Expansions to KK Finishers and Brighton Finishers**

Ryan Robertson owns and operates KK Finishers and Brighton Finishers in northeast Jefferson County. The CAFOs are located at 1031 Quince Avenue in Penn Township and 1083 Germantown Road in Walnut Township, respectively. Each CAFO presently has two buildings housing a total of 2490 hogs at each site. The expansions would add an additional 1200 hogs to each location and entail constructing a new confinement building at each facility.

A public hearing was held on December 22 at the Jefferson County Courthouse to hear comments and score the Master Matrixes for both facilities. JFAN cited that the 30 points taken on both matrixes for no violations within five years should be disqualified since Mr. Robertson, with a history of violations, had a violation as recently as four years ago. Brighton Finishers had a requested scoring of 470, which was then reduced to 440 points, the minimum passing grade out of 880. KK Finishers, starting at 440 points, was brought down to 430.

To complicate matters, Mr. Robertson submitted a revised a Master Matrix for KK Finishers just hours before the public hearing. Since there was no time for a review before the public hearing, the new matrix was not considered and based on the 430 score of the original Master Matrix, the supervisors denied recommending that the DNR approve KK Finishers' construction permit.

In addition, Mr. Robertson also submitted a revised Master Matrix for Brighton Finishers, but the supervisors assumed it only removed the 30 points to bring it to 440. It wasn't until the next day that JFAN discovered that some of the other scoring was changed as well. However, the supervisors did pass the original Brighton Master Matrix pending DNR approval of the manure management plan.

At the public hearing, JFAN brought up several concerns, among which are Mr. Robertson's violation record and a manure management plan that appears to be insufficient for the amount of manure his facilities will produce. (JFAN's statement made at the public hearing is attached.) These are among the several points that will be discussed at the DNR meeting.

Even with county supervisor input, the DNR has final say in whether or not a CAFO is approved. This meeting with the DNR has the potential to significantly impact whether or not these expansions will occur. With your support, we can show the DNR that Jefferson County values its quality of life and environment. We hope you can join us on Thursday, January 19 at 3:00 at the Fairfield Library Community Room.

**Details on HF 589 – the "Ag gag" bill:**

- It criminalizes "tampering" with a factory farm – damaging a factory farm, killing livestock, theft, or disruption of operations. This is already illegal and is redundant
- It criminalizes "interference" with a factory farm – videoing or photographing of a factory farm and violations occurring on a factory farm would become a misdemeanor. Entering onto a factory farm (which is already trespassing) is also included as interference
- It criminalizes "fraud" of a factory farm. If someone gains access to a factory farm through false pretenses, they would be charged with a misdemeanor. Again – this is redundant. It is already against the law to seek employment by misrepresenting yourself
- It allows a factory farm to bring civil actions (sue) against anyone who commits these acts for damages up to 3 times the amount of actual damage. This section has the potential to allow factory farms to sue everyday citizens who document manure spills, dead livestock violations, and other violations that may occur at factory farms.
- This bill applies these same violations to "crop operations" which is loosely defined as a location where a crop is maintained. a crop field, orchard, nursery, greenhouse, garden, elevator, seedhouse, barn, or warehouse

**Details on HF 589 – the “Ag gag” bill:**

- It criminalizes “tampering” with a factory farm – damaging a factory farm, killing livestock, theft, or disruption of operations. This is already illegal and is redundant.
- It criminalizes “interference” with a factory farm – videoing or photographing of a factory farm and violations occurring on a factory farm would become a misdemeanor. Entering onto a factory farm (which is already trespassing) is also included as interference.
- It criminalizes “fraud” of a factory farm. If someone gains access to a factory farm through false pretenses, they would be charged with a misdemeanor. Again – this is redundant. It is already against the law to seek employment by misrepresenting yourself.
- It allows a factory farm to bring civil actions (sue) against anyone who commits these acts for damages up to 3 times the amount of actual damage. This section has the potential to allow factory farms to sue everyday citizens who document manure spills, dead livestock violations, and other violations that may occur at factory farms.
- This bill applies these same violations to “crop operations” which is loosely defined as a location where a crop is maintained – a crop field, orchard, nursery, greenhouse, garden, elevator, seedhouse, barn, or warehouse.

**Update on KK Finishers & Public Hearing Date – January 27, 2012**

**Update on KK Finishers Expansion Master Matrix Scoring and Public Hearing Date**

**Background**

Ryan Robertson has applied for construction permits to expand two of his existing CAFOs near Pleasant Plain. Currently, each CAFO houses 2490 hogs. He is proposing to expand each to house 3690 hogs. Because these CAFOs will be expanded to over 2500 hogs, Mr. Robertson is required to apply for a construction permit, which must be approved by the DNR. Additionally, as with all new or expanding CAFOs over 2500 hogs, Mr. Robertson must receive a passing score (440 out of 880 points) on the Master Matrix test for each CAFO. The County Board of Supervisors scores the Master Matrix.

**Update and Public Hearing Announcement**

Last Monday, January 16, during their weekly board meeting, the Jefferson County Board of Supervisors postponed scoring KK Finishers’ Master Matrix in order to research the validity of some of the points taken by Mr. Robertson. Based on their findings, the supervisors voted during this week’s meeting to not approve KK Finishers’ Master Matrix.

The supervisors noted that Mr. Robertson had taken 25 points for Question 22 concerning an applicant’s ability to take the Homestead Tax Exemption. Individuals qualifying for these points must have a home on the same property as the confinement or on a contiguous piece of land. JFAN was prepared to address this point at the meeting, but it proved unnecessary. Supervisor Steve Burgmeier reported that Jefferson County Assessor Sherri Blough-Neff could not provide any proof or documentation that Mr. Robertson did reside at the Quince Avenue CAFO site. There is no home there, nor does he live on a contiguous piece of property.

Mr. Robertson had scored his Master Matrix at 440 points, the minimum passing grade. Deducting the 25 unqualified points, the supervisors scored it at 415 points, a failing score.

At the January 16 supervisors meeting, the board decided to schedule a public meeting on KK Finishers' Master Matrix on **Thursday, February 2 at 4:30 pm in the Courtroom at the Jefferson County Courthouse**. This week, they discussed whether to still hold the meeting even though the Master Matrix didn't pass. At the advice of assistant county attorney Pat McAvan, the supervisors agreed to go ahead with the public hearing next Thursday as it will provide an opportunity for both sides to make public comments for or against the KK Finishers expansion.

**Even though the supervisors are prepared to deny the Master Matrix based on the failing score and recommend to the Iowa Department of Natural Resources (DNR) against the expansion, JFAN encourages the community to still attend this meeting to reinforce that decision and to address any unanticipated developments.**

JFAN will again make public comments against the expansion, and we will be prepared for any unexpected changes in the scoring procedure. Should the supervisors follow through with a denial, the recommendation for denial will then go back to the DNR who will review the Master Matrix and construction permit at that time. The DNR has final say in whether or not a construction permit is issued for a CAFO.

#### **JFAN and Iowa CCI in Meeting with DNR Last Week**

On Thursday, January 19, JFAN and Iowa Citizens for Community Improvement (CCI) made a solid, fact-based presentation to the Iowa DNR advising against approval of the construction permits for both facilities. JFAN presented weaknesses in both Master Matrixes and the inadequacies of the manure management plans that were initially brought out at the December 22 public hearing. Since that time, JFAN has uncovered additional problems with the amount of manure proposed to be applied to the fields in the manure management plans, including discovery that Mr. Robertson was using the same fields for manure application in a third CAFO he owns. The DNR did not previously know about this double dipping.

The DNR listened to our arguments and will be following up on the points we raised. Director Roger Lande was to attend this meeting, but backed out at the last minute. We were fortunate to have Gene Tinker, Head of Animal Operations; Dennis Ostwinkle, Supervisor of the Washington Field Office; and Bert Noll, Environmental Specialist in Animal Feeding Operations from the Washington office, attend the meeting.

According to County Attorney McAvan, should Mr. Robertson submit a new Master Matrix prior to the February 2 public hearing, as was done prior to the December public hearing, it will not be considered, and the hearing will center on the current Master Matrix. If the supervisors follow through with a final recommendation against approval of KK Finishers' Master Matrix, Mr. Robertson will not have an opportunity to submit a new Master Matrix before the approval process returns back to the DNR. If the DNR concurs with the supervisors, the CAFO will not be approved. If Mr. Robertson intends to pursue this expansion, he will have to start the process all over again with a new construction permit application and \$500 filing fee.

The supervisors conditionally recommended approval for Brighton Finishers pending DNR approval of the manure management plan at the December 22 public hearing. The DNR is continuing its investigation and review of the application, especially in light of JFAN's findings. A final decision is yet to be made. JFAN will keep you posted on any further developments.

A uniquely even-handed look at how animals are raised in the US, *American Meat* chronicles America's grass-roots revolution in sustainable locally based farming and explains how America arrived at its current industrial system. The documentary, which features several Iowa farmers and agricultural leaders, will be screened on Tuesday, February 28, at the Fairfield Public Library beginning at 7:30. A panel discussion with New York City filmmaker Graham Meriwether will follow. Admission is free.

Meriwether shows feedlots and confinement houses, not through hidden cameras, but through the eyes of the farmers who work in them. The story shifts to the burgeoning sustainable local-food movement of farmers, chefs, and everyday folks who might just change everything about the way meat reaches the American table.

Meriwether and his team spent four years traveling across the country interviewing both farmers pursuing alternative livestock systems and those who work for industrial production systems, taking care to provide a balanced human perspective at the economic and environmental issues facing farmers today.

Iowans featured in the film include farmers Chuck Wirtz of West Bend and Paul Willis of Thornton; Dave Murphy and Lisa Stokke, leaders of Food Democracy Now!; and agronomist Fred Kirschenmann of the Ames-based Leopold Center for Sustainable Farming.

The 85-minute feature is the first from Leave It Better, a non-profit, solutions-based environmental organization founded by Meriwether.

**An urgent clean water action alert from Iowa CCI**

A big-moneyed corporate ag interest group called the Iowa Association of Business and Industry (ABI) has proposed a new rule to the Department of Natural Resources (DNR) that, if passed, will weaken the DNR's ability to crack down on factory farm polluters who violate our clean water laws and signal to the industry that the DNR is going to take a "hands-off" approach to enforcement.

**Will you join us next Tuesday, March 20 and speak out at the Environmental Protection Commission's (EPC's) meeting to demand the DNR stop kowtowing to the corporate factory farm industry and start standing up for clean air and clean water?**

We'll meet at the CCI statewide headquarters, 2001 Forest Avenue at 9am and then head out to the DNR Air Quality Control Building, 7900 Hickman Road in Windsor Heights in time for the 10am EPC meeting.

Imagine a factory farm operator a mile from your local community spills 10,000 gallons of toxic manure into a tile line that runs into a nearby river, lake, or stream, resulting in hundreds of fish kills. Now imagine instead of investigating the spill and levying the toughest fines and penalties allowed by law, the DNR has an "informal meeting" with the operator, and sends a "letter of noncompliance" asking them not to do it again. **Does that sound like a good deterrent to you?**

The sad thing is, *the DNR already does this in too many cases*. But the new rule being pushed by ABI would formalize this bad policy in writing, making it more difficult for everyday people to ensure strong and effective public oversight of factory farm polluters in the future, even if priorities shift in two years with a new governor and a new DNR director.

The EPC meeting March 20 is our first shot out of the gate to take on ABI's new rule proposal, and a strong public showing on Tuesday will set up the next two steps in this fight. **Will you be there to stand up for a good government that puts communities before corporations and people before profits, politics, and polluters?**

***From Iowa Citizens for Community Improvement***

We write with good news and to ask for three minutes of your time.

The good news: We stopped a factory farm from being built in Dallas County!

Over the last two weeks, we've been working with about 60 people in the area to stop a 5,000-head Cargill-backed hog factory. And, yesterday, a Dallas County Supervisor hand-delivered the official word to CCI members Rick & Stacy Hartmann's home that the developer dropped his plans. (*Read the letter at the end of this email.*)

This is a huge victory, and we won because members and others worked together, stayed hopeful, used a lot of creativity and refused to give up. They engaged the developer directly, got our message out to the public through the media and a very visible picket outside the developer's business and even sent a Mother's Day card to the developer's wife asking her to consider the concerns of the other neighborhood mothers.

**This news also means that CCI members, like you, have stopped four factory farms in the past two months thanks to tough organizing and putting pressure where it needs to be put.** That's no small accomplishment. You should be very proud.

Take three minutes to help us turn in 500 comments to the DNR:

Right now Iowans in twelve counties are fighting to stop more than 20 new or expanding hog factory sites <http://iowacci.org/in-the-news/surge-in-factory-farm-construction/>. **Why?** In large part because the laws on the books put corporate ag polluters and their profits before the common good and our land.

No where is that more evident than in the bad rule the Iowa Association of Business and Industry is trying to pass right now. **The ABI is trying to put force our Department of Natural Resources to take a "hands off" approach to factory farm enforcement which means more factory farms and more manure in our water. We need your help to stop it.**

So far 254 Iowans have submitted comments to the DNR to help stop this ridiculously bad rule. We need you to take action, too.

**EPA says DNR is lax on enforcing confinement permits, regulations**

Iowa's permitting program for large-scale animal agricultural operations is deficient and must make improvements, the U.S. Environmental Protection Agency reported on Thursday.

The report found that the state Department of Natural Resources in some cases has not conducted the inspections necessary to determine whether confined animal feeding operations, called CAFOs, need to be permitted and has not issued permits for some operations as required by federal law.

The department also has failed to act on permit violations and does not have adequate penalties in place for those violations.

"As a national leader in beef, swine and poultry production, with roughly 7,000 animal feeding operations, it is imperative that Iowa have an NPDES permitting, compliance and enforcement program that complies with federal law and protects the quality of Iowa's rivers, lakes and streams," said EPA Region 7 Administrator Karl Brooks.

The National Pollutant Discharge Elimination System, or NPDES, is the EPA program that sets minimum requirements for confinement regulations.

The DNR now has 60 days to offer a formal response outlining how it will correct the problems identified.

A spokesman for Gov. Terry Branstad said Thursday evening that the administration had just learned of the report and was examining the issue. DNR officials couldn't be reached for comment.

The report is the result of a petition filed in 2007 by Iowa Citizens for Community Improvement, the Sierra Club and the Environmental Integrity Project. In their petition, the groups sought to strip the DNR's authority to regulate and enforce federal environmental laws related to livestock farms because they believed it wasn't doing an adequate job.

Five years later, the EPA has validated those concerns, said David Goodner, an organizer for Iowa CCI.

"Basically, it says what we've all known for a long time: that the DNR's enforcement of factory farms in Iowa isn't up to par, and they need to get their act together if they want to be serious about cleaning up our water."

The EPA report identifies eight specific steps the DNR should take to "address its program deficiencies," including more consistent and comprehensive inspections and revisions to the way it enforces the clean-water laws on confined animal feeding operations.

## **Whose Side Is the American Farm Bureau On?**

The American Farm Bureau, with its 6 million "member families" and carefully cultivated grassroots image, talks a good game. In the pitched battle over US farm policy--with agribusiness giants on one side, and small family farmers, organic and local food advocates and environmentalists on the other--the Farm Bureau positions itself as the voice of the farmer.

"If you know agriculture in this country, it is dominated by family farms, and those are the people who come to our meetings, those are the people who set our policies," claims Mark Maslyn, executive director of the American Farm Bureau Federation's public policy department, a team of twenty-two registered federal lobbyists that spend more than \$2 million annually on a variety of agriculture issues.

But Rolf Christen, a cattle farmer in Missouri who was at one time an enthusiastic member of his local farm bureau's board, tells a different story.

Christen realized that the bureau's "family farmer" talk was cheap when he sought its help battling an industrial scale hog operation with 80,000 animals just up the road from his farm in northern Missouri beginning in 1993. The waste from the facility created a sickening, eye-watering stench that seeped across the land and into the homes of Christen and his neighbors, starting what would be an epic battle against Concentrated Animal Feeding Operations (CAFOs) that continues to this day. At that time, Christen had become the leader of local resistance to the CAFO, then owned by Premium Standard Farms. He organized town meetings and lobbied elected officials to fight Premium Standard. But he hadn't counted on also fighting his local Farm Bureau, which he had joined as a young farmer in 1983, even getting involved with state legislative issues. When it came to this fight, the Farm Bureau sided with Premium Standard and cut Christen and his small farmer friends loose.

"All of a sudden laws were changed in the state in order to make it easier for [Premium Standard], and that's where the Farm Bureau and I quickly parted ways," said Christen. Then, and to this day, Christen says, the "Farm Bureau has always supported the industry...and not the small farmers."

How had this happened? Missouri had become a popular destination for the pork industry. The state produces millions of pigs a year, predominantly for Smithfield Foods, the world's largest pork producer, which purchased Premium Standard in 2007. The rise of the factory farm has been the death knell for the small family farmer in Missouri, as it has across the country. In 1964, there were 62,000 pig farms in Missouri; as of 2007, there were about 3,000, producing roughly the same number of pigs. To these giant hog producers, who depend on the support of the Farm Bureau to keep their efficient model humming, farmers like Christen and their worries about air and water quality are little more than troublemakers.

Although illustrative, Christen's case is not unusual. From California to New York, the Farm Bureau leads the charge for industrial-scale food production. It opposes the labeling of genetically engineered food, animal welfare reform and environmental regulation. In Washington, its well-funded team of lobbyists and lawyers seeks to undermine the federal Clean Water Act and the Clean Air Act, opposing pesticide restrictions and increased scrutiny of greenhouse gas emissions and pollution from CAFOs, like the "farm" up the road from Christen.

The Farm Bureau has sued the EPA, which is trying to limit farm runoff from polluting the Chesapeake Bay. At the same time, the Bureau pushes hard to expand international trade and lobbies for the stream of government subsidies that disproportionately benefit the nation's biggest commodity farm operations and, indirectly, the agribusinesses at the heart of this system.

In Washington, the 2012 Farm Bill has predictably been a top priority for the Farm Bureau lobby team. They have surprised players from both sides of the debate by conceding cuts in traditional subsidies in exchange for a large expansion of subsidized crop insurance that protects against disasters and falling prices at an estimated cost to taxpayers of \$9 billion a year [3]. The tactical, philosophical shift garnered praise even from Farm Bureau adversaries. Nonetheless, it should be noted that crop insurance is a small, but significant piece of Farm Bureau insurance companies' portfolio. In 2011, they collected over \$300 million in crop insurance premiums.

In rural areas, the Farm Bureau grooms compliant political candidates, mostly Republicans; it wields the power to dictate outcomes of legislative elections and appointments to powerful state agriculture committees. Then it influences which farm-related bills become law. Along the way, it has become a close second to Monsanto in lobby expenditures for agriculture-related issues, spending nearly \$6 million in 2011 --all in the name of "farmers."

American Farm Bureau Federation president Bob Stallman was succinct, almost militant in his opening address last year at the group's annual meeting: "We will not stand idly by while opponents of today's American agriculture...try to drag us down...try to bury us in bureaucratic red tape and costly regulation--and try to destroy the most productive and efficient agricultural system in the world," he said.

Stallman could well have been talking about Christen and his neighbors.

\* \* \*

Christen has firsthand experience with the underbelly of that efficient system, because hog-raising is a messy business. Although afforded similar status to farms, CAFOs are more like automobile assembly-line factories, where thousands of animals are birthed, nourished with corn and other grains and supplemented with antibiotics and growth-promoting supplements. They are raised in climate-controlled darkness, confined to pens so cramped they cannot turn around. Hogs produce four times the waste of humans, and these CAFOs produce millions of gallons of manure annually. But in cities, human waste ends up at a sewage treatment plant; in CAFOs, untreated livestock waste is flushed out of confinement buildings into large lagoons, sprayed on fields as fertilizer and then too often migrates into streams and groundwater. In Missouri, this waste not only fouls the air; it has made its way into the rivers, streams and groundwater of surrounding communities.

By 1995, Christen had found two local farmers, Terry Spence and Scott Dye, to join him in his fight. Rebuffed at every turn by the Farm Bureau, elected officials and regulatory agencies, they concluded their only hope was in the courts. So, they went lawyer shopping and found an unlikely candidate in Charlie Speer, a Kansas City attorney, who was once a financial analyst for Ford Motor Company and then represented corporate polluters who had fallen out of favor with the EPA.

The three men provided Speer with evidence of a litany of infractions by Premium Standard's operation--breaches of their lagoons, runoff from spreading manure on the land, burst pipes that sent hog waste flowing into streams, lakes and onto neighboring properties, causing miles of polluted streams and killing fish. Speer would soon discover that Premium Standard operations emit more ammonia and hydrogen sulfide than any other industry in Missouri. Neighboring farmers would later testify about the effects of the ubiquitous odor--burning eyes, noses and throats, gagging, nausea, vomiting and headaches.

In fact, Smithfield and its subsidiaries have been the subject of numerous environmental enforcement actions by the state and the federal government over water and air pollution caused by their hog production factories. From 1997 to 2004, Smithfield was fined \$19 million. Bo Manly, president of Premium Standard at the time and now executive vice president and chief financial officer at Smithfield, admitted in a deposition with Speer that Premium Standard was the most fined agriculture company in Missouri.

"I quickly learned that the ag industry today is like when I was working at Ford Motor," Speer said. "It's cheaper to pay the fines and keep dumping the paint in the creek."

With this kind of evidence in hand, Speer initially thought the case was a slam-dunk and easy money. It would be neither. In 1997, Christen and 60 of his neighbors formed the Citizens Legal Environmental Action Network, or CLEAN. With Speer as their counsel, they filed a federal citizens-action suit against Premium Standard alleging improper waste disposal near their homes. In 1999, the US EPA intervened in the suit, joining CLEAN as a co-plaintiff against Premium Standard.

After the CLEAN suit was filed, Premium Standard spokesman Charlie Arnot weighed in with his view, one that has dominated the national discussion over food: "I think people need to understand that this [CAFO] is part of an ongoing changing structure in agriculture.... It's a different model than we've ever seen before. Is it the right model? Not for everybody. But I think communities that want to continue to sustain a quality rural way of life have to begin to look beyond what we've always looked at in the past."

Christen and CLEAN--fully aware of what that "quality rural way of life" means--emerged victorious in its lawsuit, leading to a 2002 federal consent decree requiring Smithfield and Premium Standard to clean up its act. But enforcement is still being argued in the courts by both sides, and, Christen says, the air at his house still stinks. "It pisses me off that after fifteen years the company still does not even acknowledge that there is

a problem up here," he says.

As it turned out, Christen and his friends weren't an anomaly. Since meeting with the group, Speer has racked up big damage awards on behalf of individual farmers living next to these hog CAFOs throughout Missouri. In 2010, Speer attracted national attention with a record \$11 million verdict awarded to fifteen plaintiffs who had been subject to the foul odors emanating from a Premium Standard pig CAFO in northwestern Missouri. In total, Speer has won over \$25 million for 101 neighbors of CAFOs in eight "odor nuisance suits," as they are called.

To date, Speer has filed nearly 500 odor nuisance complaints in seven states, roughly half in Missouri. In one of Speer's odor cases, it became evident that the Missouri Farm Bureau had more than a philosophical interest in the issue. A Missouri Farm Bureau insurance affiliate (that's right, those family farmers at the Farm Bureau have a big hand in the insurance industry) was the carrier for one of the hog producer defendants. It paid \$550,000 to settle the case, and also paid the defendant's legal bills.

The court battles have become a threat to the bottom line of America's biggest pork producers. In fact, Smithfield Foods threatened to pull all of its hog operations out of Missouri after Speer's \$11 million judgment--and that put the issue front and center for the Missouri Farm Bureau.

In response, the Farm Bureau moved the battlefield to its favored arena--the Statehouse floor --with a bill from a friendly legislator the bureau helped elect. The aim of the bill: to keep all the farmers like Christen from seeking meaningful legal redress against the pollution from CAFO operations.

In the waning days of the 2011 Missouri legislative session, Senate Bill 187 was signed into law, limiting citizens' ability to sue large agribusinesses over the harm their factories inflict on neighboring property owners. The Farm Bureau had been pushing various forms of this bill for years, but with a Republican surge in the 2010 legislative elections and a new crop of freshman legislators, it finally passed. Though its sponsors spun the bill as protection for family farmers, it was, in reality, exactly the opposite. Senate Bill 187 limits the number of times a farmer can sue and caps damages at property value, which of course have decreased after the CAFOs moved in.

Despite its track record, the Farm Bureau insists it has been and always will be the champion of the small farmer and rural America. To those who claim the Farm Bureau has sided squarely with one side, against the interests of many farmers, the Bureau's Maslyn responds, "I'd say they've never been to one of our meetings."

Christen takes issue, as do a growing number of small farmers: "The point is, operators that raise hundreds of thousands of animals in confinement are 'industrial operations' and need to be regulated. And the Farm Bureau is never going to concede to this," he said. "Their argument and scare tactic was and is: If we regulate the 'big' guys, we will have to regulate the 'little guys' also. Soon it will be too late, there will not be any family farmers left. But why would the Farm Bureau worry; they will sell their insurance anyway. The billboard in my town reads: 'You don't have to be a farmer to insure with us.' "

\* \* \*

Christen is referring to that other, lesser-known facet of the Farm Bureau. It's not just a non-profit "farmers organization" but a multi-billion dollar network of for-profit insurance companies, the third-largest insurance group in the United States. Its premiums generated more than \$11 billion last year alone, on top of has assets worth more than \$22 billion. In many states, Missouri among them, members of the Farm Bureau board and the board of its affiliated insurance company are one and the same, sharing office buildings and support staff.

And those 6 million farmers it claims as members? In many states, anyone who signs up for Farm Bureau insurance becomes a member of the Farm Bureau automatically, which explains why the American Farm Bureau Federation boasts 6 million members when the United States has only about 2 million farmers. In Missouri, less than a third of its members are farmers. Nonetheless, all of its 113,000 members pay annual dues, as they do throughout the country, which fuels a potent political machine.

In addition to the American Farm Bureau Federation's twenty-two lobbyists, no fewer than 20 of the state Farm Bureaus, including Missouri, have registered lobbyists in Washington, leading the field of agribusiness lobbyists. Over the past decade, the nation's ten largest agribusiness interests gave \$35 million to Congressional candidates--led by the Farm Bureau, which gave \$16 million, or 45 percent of the total. Farm Bureau PACS donated another \$16 million to state candidates, according to election records.

The Farm Bureau also has a financial interest in agribusiness corporations. In recent years, its insurance affiliates have bought stock in companies like Cargill, ConAgra, Dow Chemical, DuPont, Tyson and Archer

Daniels Midland, all major food industry players. The Southern Farm Bureau Annuity Insurance Co. once owned more than 18,000 shares of Premium Standard stock.

It has also grown increasingly concerned about the mounting resistance to the get-big-or-get-out agribusiness model, which has led increasing numbers of farmers and consumers to seek out alternatives.

So the American Farm Bureau has pushed into public relations, spearheading the launch of the U.S. Farmers and Ranchers Alliance, an advertising/social media/PR campaign to paint agriculture in a more favorable light. With an \$11 million annual budget and most of the national commodity groups on board, the big ag-business players are now joining--DuPont, John Deere, Monsanto and BASF.

"Our adversaries are smart and resourceful," said the American Farm Bureau's Stallman, who also heads the Farmers and Ranchers Alliance. "But we're now matching them in using new communications tools, new strategies and new tactics." The group's promotional videos display polished vignettes but they are not filmed inside CAFOs; rather they are shot in sunlit fields of wheat and corn with attractive and articulate family farmers and distributed to partners such as the Discovery network on cable TV. It is the Rockwellian image of the farmer America loves, and one the Farm Bureau uses to pursue public approval for its agenda--and against small farmers like Christen.

Christen, now 58, is still fighting Premium Standard and the Farm Bureau; it has pretty much consumed his life. Now, a 140,000 hog factory is located seven miles south of him. As his original lawsuit drags on, the stench persists. Whether Speer's legal barrage proves to be a game-changer or merely an aggravating blip on the EKG of corporate agriculture has yet to be seen. It's also unclear whether the voices of small farmers, like Christen, will be strong enough to counter the ingrained image of the Farm Bureau as their savior and protector.

"There's only so many times you can tell farmers you're acting in their interest, and then act in the complete opposite manner," says Rhonda Perry, a Missouri farmer and a former Farm Bureau "princess" who runs the Missouri Rural Crisis Center, a grassroots organization supporting family farmers. "So, now they're saying we have to convince the consumers that agriculture is good and this new way of producing animals is really the best way."

Then she sighs.

"As long as you have money to perpetuate the myth, the war is going to go on and on and on...."

**Opportunity for Public Comment to EPA about Iowa DNR – October 9, 2012**

**Opportunity for Public Comment to EPA about Iowa DNR**

Iowans have two opportunities to let the Environmental Protection Agency (EPA) know how they feel about the way the Iowa Department of Natural Resources (DNR) regulates CAFOs.

The EPA issued a report in July that criticized the way in which the DNR regulated water pollution from CAFOs. The EPA faulted the DNR on several points (see below). The DNR responded in September with a number of action steps.

2. The EPA is also holding a public meeting on **Thursday, October 18 at 7:00 pm in Des Moines** in order to hear directly from Iowa residents about the problems with CAFOs and how CAFOs can be better regulated to protect people and the environment.

**Background:**

The EPA conducted an investigation of the DNR after three environmental organizations – Iowa Citizens for Community Improvement, Sierra Club, and the Environmental Integrity Project – threatened to sue the EPA for not enforcing the federal Clean Water Act in Iowa.

The Clean Water Act requires a factory farm to have a National Pollutant Discharge Elimination System (NPDES) permit to operate. It provides an additional level of oversight. Currently only cattle feedlots in Iowa are required to have NPDES permits. This only comprises less than 5% of all of Iowa's industrial livestock, according to the most recent USDA figures.

In its July 12 report, the EPA faulted the DNR on several points including:

- Not issuing required Clean Water Act permits to CAFOs
- Not having an acceptable system to determine which factories need permits
- Not having an adequate inspection program
- Failing to act in cases of CAFO Clean Water Act violations
- Not following its own response policy in nearly 50% of the cases the EPA reviewed
- Failing to assess adequate penalties for Clean Water Act violations.

The DNR was required to issue a response within 60 days. On September 11, it provided a response with the following action steps:

- Commencing new rulemaking, beginning November 1, 2012, to ensure compliance with the Clean Water Act
- Requesting additional funding from the State Legislature for 13 new full time field staff
- Bringing Iowa's regulatory program up to federal standards by changing existing protocols and procedures

As reported in the *JFAN Fall/Winter 2012 Newsletter*, Tarah Heinzen, attorney for the Environmental Integrity Project, said, "Permitting rules are a long overdue first step, but they will not lead to real improvements in water quality if the DNR continues to assume that the state's factory farms are meeting its 'zero discharge' standard. The DNR's work plan does not adequately address the EPA's finding that the DNR cannot even currently identify confinements in need of these permits. Clearly rules alone will not be enough."

Iowa CCI's Adam Mason was quoted as saying, "The proof is in the pudding. We'll wait and see what the rulemaking looks like, if it is just lip service – weak but enough to satisfy the EPA – or a good rule."

Additional funding for new full time field staff would have to be approved by the State Legislature and signed into law by Governor Branstad during the upcoming legislative session.

**KK Finishers Tries to Expand Again  
December 26 Public Hearing Scheduled**

JFAN has learned that Ryan Robertson has submitted a new CAFO and Master Matrix application for a 1200-head expansion to KK Finishers, located just north of Pleasant Plain in Penn Township.

This is the same facility Robertson attempted to expand last year. That application was subsequently withdrawn when the Jefferson County Board of Supervisors determined the Master Matrix didn't meet the minimum score of 440 points.

KK Finishers currently contains 2490 hogs. The expansion would add a new building and bring the total number of hogs to 3690 head.

In addition, it would bring the total number of hogs within a one-mile radius of Pleasant Plain city limits to 8460.

The Jefferson County Board of Supervisors has scheduled a **Public Meeting for Wednesday, December 26 at 7:00 pm**. This meeting is open to the public, and the community is encouraged to attend and make comments on the expansion. Comments may also be submitted in writing to the Board of Supervisors by the

end of the day on December 26.

The Board of Supervisors will be scoring the Master Matrix on **Monday, December 17 at their 9:00 am weekly board meeting**. JFAN will be in attendance. This meeting is also open to the public.

JFAN currently is reviewing the Master Matrix and Manure Management Plan (MMP).

#### **Update on Brighton Finishers**

JFAN recently learned that the 1200-head expansion to Brighton Finishers on Germanville Road, also owned by Ryan Robertson, has been approved, culminating a nearly yearlong process.

JFAN contested the validity of Brighton Finishers' MMP last December as the field residue levels observed by JFAN Board Member Francis Thicke did not match the figures indicated on the MMP. Thicke photographed the fields and filed a complaint with the DNR.

The DNR forwarded the complaint to the National Resources Conservation Service (NRCS) of the US Department of Agriculture, and members of the NRCS were to evaluate the fields in question. However, Robertson refused to have the NRCS examine his property, and kept extending the permit application through this summer's growing season.

In September, the DNR conditionally approved the manure management and construction permit, with the stipulation that before Robertson could apply any manure to his fields, he must submit to an NRCS inspection.

Robertson finally allowed the NRCS to come to the land in late fall, and the field officer found that the residue measurements were very close to those indicated on the MMP. Brighton Finishers was given the final OK for the expansion.

In JFAN's opinion, the DNR did not address the original complaint, that Robertson was out of compliance in 2011 with his MMP, and the delay allowed by the DNR enabled Robertson to eventually come into compliance after the 2012 growing season.

It is our opinion that the CAFO should have been denied by the DNR last winter and punitive action taken on the complaint.

In October, JFAN presented the handling of this expansion to representatives of the Environmental Protection Commission who were investigating the DNR's lack of enforcement of the Federal Clean Water Act.

The Board of Supervisors will be scoring the Master Matrix on **Monday, December 17 at their 9:00 am weekly board meeting**. JFAN will be in attendance. This meeting is also open to the public.

JFAN currently is reviewing the Master Matrix and Manure Management Plan (MMP).

#### **Update on Brighton Finishers**

JFAN recently learned that the 1200-head expansion to Brighton Finishers, also owned by Ryan Robertson, has been approved, culminating a nearly yearlong process. JFAN contested the validity of Brighton Finishers' MMP last December as the field residue levels observed by JFAN Board Member Francis Thicke did not match the figures indicated on the MMP. Thicke photographed the fields and filed a complaint with the DNR.

The DNR forwarded the complaint to the National Resources Conservation Service (NRCS) of the US Department of Agriculture, and members of the NRCS were to evaluate the fields in question. However, Robertson refused to have the NRCS examine his property, and kept extending the permit application through this summer's growing season.

In September, the DNR conditionally approved the manure management and construction permit, with the stipulation that before Robertson could apply any manure to his fields, he must submit to an NRCS inspection.

Robertson finally allowed the NRCS to come to the land in late fall, and the field officer found that the residue measurements were very close to those indicated on the MMP. Brighton Finishers was given the final OK for the expansion.

In JFAN's opinion, the DNR did not address the original complaint that Robertson was out of compliance with his MMP, and the delay allowed Robertson to eventually come into compliance after the 2012 growing season.

It is our opinion that the CAFO should have been denied by the DNR last winter and punitive action taken on the complaint.

In October, JFAN presented the handling of this expansion to representatives of the Environmental Protection Commission who were investigating the DNR's lack of enforcement of the Federal Clean Water Act.

#### **KK Finishers Tries to Expand Again December 26 Public Hearing Set**

JFAN has learned that Ryan Robertson has submitted a new CAFO and Master Matrix application for a 1200-head expansion to KK Finishers, located just north of Pleasant Plain in Penn Township.

This is the same facility Robertson attempted to expand last year. That application was subsequently withdrawn when the Jefferson County Board of Supervisors determined the Master Matrix didn't meet the minimum score of 440 points.

KK Finishers currently contains 2490 hogs. The expansion would add a new building and bring the total number of hogs to 3690 head.

The Jefferson County Board of Supervisors has scheduled a **Public Hearing for Wednesday, December 26**

**at 7:00 pm in the Courtroom of the Jefferson County Courthouse.** This meeting is open to the public, and the community is encouraged to attend and make comments on the expansion. Comments may also be submitted in writing to the Board of Supervisors by the end of the day on December 26.

## **Good News! Supervisors Give Thumbs Down to KK Finishers Expansion – December 30, 2012**

### **K Finishers Update:**

#### **Board of Supervisors Do Not Recommend Approval of CAFO Expansion**

At the Wednesday, December 26 Public Hearing, the Jefferson Board of Supervisors voted to not recommend approval of the 1200-head expansion to KK Finishers, a 2490-head CAFO owned and operated by Ryan Robertson just north of the city of Pleasant Plain. They scored the Master Matrix at 400 points, deducting 40 points for questions they felt were not adequately answered.

Several JFAN board members attended the public hearing and made comments disputing the validity of points taken on four of the questions. A neighbor who owns an herb farm near the proposed expansion also expressed concerns over the expansion.

JFAN attended all meetings of the Board of Supervisors where the Master Matrix to KK Finishers was examined and presented several concerns with points taken. The supervisors had many questions of their own, as well.

JFAN would like to thank the supervisors for their thorough review of the Master Matrix and for their recommendation to not approve the expansion of the CAFO to the DNR.

The DNR has the final say on whether or not the expansion to KK Finishers will be approved. Considering their approval of the Brighton Finishers expansion this fall, there is no guarantee that the DNR will deny the application for KK Finishers. JFAN will continue to monitor this situation with the DNR.

#### **Supervisors not recommending approval of new hog facility plan**

The Jefferson County Board of Supervisors will recommend not approving KK Finisher's construction application to the Department of Natural Resources for building a new 1,200-head deep-pit swine finisher barn at an existing hog facility north of Pleasant Plain.

At a public hearing Wednesday night attended by about a dozen people, the supervisors gave the amended Dec. 19 Master Matrix a score of 400 points. To pass, the matrix needs a minimum of 440 points out of 880. The application was submitted and amended meeting the minimum 440 points.

A few members of the public spoke; two people asked the supervisors not to recommend the application to the DNR and one neighbor pointed out why expanding the existing 2,200-head hog confinement feeding operation could economically hurt the neighbor's farming and gardening operations.

"We're open to the public for comment," said supervisor chairman Steve Burgmeier. "At some point, we'd like written comments submitted to forward to DNR."

Diane Rosenberg, executive director of Jefferson County Farmers and Neighbors Inc., and Jim Rubis provided written comments and spoke to the board.

"After reviewing the Master Matrix and its revision, it appears to me it does not deserve to be approved," said Rubis. "The applications were turned in with the minimum allowable scores. Very few of the points applied for [by owner Ryan Robertson] have any explanation nor do they establish or defend why they are justified."

"Based on this cavalier attitude, and Mr. Robertson's history of poor compliance, violation of rules, and incorrect or even false representation of matrix points both this year and last, it is hard to believe that he will

take seriously the construction and operation rules that are in place to protect the environment and the neighbors to his operation," said Rubis.

No one attending the public hearing spoke on behalf of KK Finisher. Burgmeier said Robertson was in Mexico, attending a long-planned Christmas family vacation.

"I thought Pinnacle would be here," said supervisor Dick Reed.

Pinnacle of Iowa Falls is an agronomic and environmental consulting firm hired by Robertson to oversee his business. At Wednesday morning's regular supervisors meeting, John Everly, a manure management and soil-sampling specialist from Pinnacle, attended and addressed questions about the amended Master Matrix submitted by KK Finisher.

"Since he was in town this morning and hung around until noon, I thought he'd get a hotel room and come to this public hearing," said Reed.

Rosenberg went through the matrix, highlighting points taken for items that were questionable.

Points taken by KK Finisher for being an additional 250-feet distance away from the closest water source above the minimum 500-foot requirement awards five points.

"The measurement is within 1.29 feet as determined by Pinnacle's measurements and within 5 feet from the creek to the west of the proposed confinement building according to DNR measurements last year," said Rosenberg.

KK Finisher had applied for a construction permit for this same site a year ago and the Master Matrix at the time failed.

"I'm asking the county engineer take a hard measurement on site," said Rosenberg. "In 2005, there was a situation with Mr. Robertson about locating in a 100-year flood plain and those measurements were off by 50 feet. That was discovered through infrared aerial views. There's been no opportunity to measure this distance accurately yet."

The matrix had 20 points for a required landscaping plan. A buffer of fast-growing and slow-growing trees planted in three rows is required to protect air and water quality at the confinement building.

"I find only a scant plan, it provides no information about the species of trees, the number or placement of trees, and there's no plan about maintaining the trees through our cold winters and conditions such as the summer's drought," said Rosenberg.

She pointed to the 10 points taken for an additional 50 feet distance above the minimum requirement for land application of manure to the closest well.

"At this morning's meeting, we learned those 10 points were taken based on recent aerial maps," she said. "Older maps need to be consulted to see if uncapped wells are in the vicinity."

A required emergency action plan was awarded five points, and Rosenberg said it was not a sufficient plan. "This matrix came in at 440 points and subtracting 40 points means it fails," said Rosenberg. "KK Finisher didn't take enough care to come in higher than the minimum required."

"Mr. Robertson has a history of complaints, and he was able to take points for no administrative orders in the past five years only because the DNR did not address a complaint brought by Francis Thicke last year," she said.

"Francis brought up Robertson was not in compliance with manure levels spread on fields. A higher *[sic]* residue than allowed was there, creating more run-offs.

"The DNR asked Natural Resources Conservation Services to evaluate the fields, but for months, Robertson would not allow them onto his fields," said Rosenberg. "Finally, after this growing season, were they allowed in — after the evidence had time to dissipate."

"It is JFAN's opinion that considering Robertson's past actions, we feel no leniency should be given in scoring his Master Matrix. It is our opinion the supervisors should not recommend a pass to the DNR."

Rosenberg thanked the supervisors for working with the public and JFAN to have input and for bringing in the DNR and Pinnacle.

A neighboring farmer to the hog facility said the smell level currently is acceptable, but adding more than 1,000 hogs might hurt the farm's business because volunteers and visitors come out to the farm to help garden and purchase herbs.

Burgmeier said Rosenberg's concerns were the same as the board of supervisors.

"If he took the points, it's up to him to prove and support his claims," he said.

Burgmeier questioned the wells item, the emergency and landscaping plans and measurements used.

"I don't think he's even measured the distances," said Burgmeier

"It wouldn't be hard with a building this size to be off by a few feet," said Reed, a lifelong building contractor.

"I see this as a two-way street. I like to see people productive; I like to see people making money," said Reed. "I agree we need to take deductions from the score on some of these items."

The supervisors unanimously voted to score the matrix with 400 points and recommend the DNR not approve the application for reasons stated in the scoring process

"I'll ask the auditor to send the public comments to the DNR by the deadline, Jan. 4," said Burgmeier.
