In the year 2012 the total number of patron visits to the library was 11,449. The library has 1206 registered resident borrowers and 214 non-resident registered borrowers. These figures do not include borrowers who are registered in other libraries but use the Poestenkill Library regularly for services. A Summer Reading Program and other special programs for patrons are held throughout the year.
