groups, service organizations, churches, city councils, etc. and radio and television interviews. All were on prohibition and drug  
policy. In an alliance with the faith based community some of the programs were made jointly with clergy.

LEAP representatives attended 46 conferences. They reached people involved in drug policy, the media, universities, law  
enforcement, politics, government and the law. LEAP sets up a booth with a video on prohibition and drug policy, talks to  
attendees and distributes flyers and other information.
