	READ MINISTRIES, INC - SUMMARY OF 2012In 2012 READ Ministries sponsored and conducted various Christian literature projects in Ukraine, Belarus and Central Asia which involved the training of evangelical church workers and the distribution of Christian literature and media resources. Following is a summary of what transpired in 2012 Church Librarian Training ProgramIn 2012 READ sponsored 5 Church Librarian Training Programs. These programs take place over a two year period and are held at Regional Bible Colleges throughout Ukraine and Belarus. In 2012 READ was able to sponsor and resource two programs in Kremenchug, two programs in Minsk, Belarus, and one program in Kherson, Ukraine. In the spring of 2012, READ was blessed to witness the graduation of a total of 45 students from our Church Librarian Training programs in Kremenchug, Ukraine and Minsk, Belarus. These students proudly marched across the stage to accept their certificate and receive their final installment of books for their church library. This means that 45 additional churches in these countries were resourced with 300 volume libraries from READ. A total of 110 students were enrolled in the READs Church Librarian Training programs during 2012. At the completion of these 5 programs, a total of 33,000 additional Christian books will have been made available to the people of Ukraine and Belarus! With the completion of these 5 Church Librarian Training Programs, over 123,000 Christian books given by READ Ministries will be circulating in Ukraine, Belarus and other parts of the former Soviet Union! In this collection of books there are books for children, youth and adults. There are books for believers and non-believers. These Christian books will enable people to gain accurate Biblical understanding, experience spiritual growth and will help satisfy the yearnings of hungry and searching hearts. The trained librarian is essential for the successful operation and effectiveness of a church and its library. In addition to our librarian training and church library projects, READ conducted a conference for Russian speaking church librarians in central and southern Ukraine in October of 2012. A total of 60 Russian speaking librarians attended the conference. This was a time for professional enrichment, problem solving for practical questions of church librarian ministry, highlighting of new titles including an exhibit of Christian literature attended by 6 publishing houses in Ukraine showing their latest titles. Each attendee received a copy of a brand new title for children, written by an American author and translated in Russian. At the end of the conference, many had tears in their eyes as they waved goodbye thanking us for the training and books provided at the conference. Church Leaders Training and Library ProjectsA second major emphasis for READ in 2012 was our Church Leaders Training and Library Projects. In partnership with our Ukrainian friends, READ has been able to equip emerging church leaders with electronic libraries and training in the use of these libraries in countries throughout Central Asia. These programs are providing church leaders a way to continue their theological education and communicate Gods love to those who are starved for His Word. READ accomplishes this by the provision of netbooks and flash drives pre-loaded with several thousand volumes of Christian media resources. Over 2012-2013 READ plans to assist the theological education and ministry efforts of over 130 Christian leaders in Ukraine, Belarus and countries of Central Asia Church Based Social Outreach Literature ProjectsDuring 2012 READ enthusiastically supplied resources to 3 church based social outreach ministries in Ukraine located in Kharkov, Poltava and Gradizhk. These outreach ministries are involved in evangelical ministry in jails, prisons and rehabilitation centers. Ministering to people who find themselves in poverty and unfortunate circumstances in this part of the world is one way READ is fulfilling Gods command to love our neighbors as ourselves Partnership SummitApproximately 22 ministry partners from Belarus and Ukraine attended our two day summit in Kremenchug, Ukraine in March of 2012. This was a time for reporting and strategic planning for our mutual Christian literature ministries.
