To maintain a comprehensive enrichment center with 24-hour assistance to persons working in Central Kentucky's thoroughbred industry, including counseling, housing and utilities assistance, food and clothing, medical and dental, referral sources, bereavement aid, farm safety classes, summer camp for low-income children, and Christmas gifts. The charity also conducts free health and dental screenings for low-wage earners and their immediate family members.

The charity addresses the issues of hunger, homelessness, health care and clothing for equine workers and their families. The "Tack Room" program stocks food, household and hygiene supplies, season appropriate clothing, and offers emergency financial aid for utilities, gas and housing, and medical care. The charity also takes fresh fruits and perishable foods to the workers who may not have transportation to the Enrichment Center. Health clinics are also offered twice a year.

4b (Code:) (Expenses \$ 43,000 including grants of \$ 14,000) (Revenue \$ 0)

The "Festival of Christmas" is our annual Christmas party featuring a hot dinner, new toys and a goody bag for each child; new winter clothing is given to the adults; and each child gets a new hat, gloves, and coat, if needed. Each family receives a food basket and ham to take home. Approximately 1,057 people were served in 2012, and over 8,000 pieces of clothing were given away.

Summer camp for low-income, at-risk children of thoroughbred industry workers is conducted annually. Thirty six children were chosen to participate in the week-long educational camp that included themed field trips, arts and crafts and life skills. The camp provides 2 meals a day, transportation, back to school supplies, clothing and new shoes.
