	Community Organizing and Civic Engagement OneAmerica advances the fundamental principles of democracy and justice by building power in immigrant communities in collaboration with key allies We do this by identifying and taking action on key issues that affect immigrants We bring immigrants together with policymakers and provide opportunities to advocate for greater access, equity, and representation within our political system Our 2012 priority issue areas included immigrant integration, racial profiling, and civil and human rights, broadly In order to help immigrants better understand and participate in the democratic process, we educate, mobilize, and engage individuals, and identify and train strong leaders In 2012, we saw major accomplishments in every program area Our Washington New Americans program, a partnership with the American Immigration Lawyers Association, provided citizenship services for eligible legal permanent residents through state and private funding We continued our organizing work with community base groups in eleven locations across the State of Washington, helping immigrants to identify issues of interest and working to educate and build leadership in immigrant communities Our Immigrants Day at the Capitol in early 2012 engaged over 300 immigrants in the democratic process by enabling immigrants to meet with their legislators Finally, our civic engagement program which focused on voter registration and education around the local, state, and federal elections met with outstanding results

	Policy, Research and Communications In 2012, OneAmerica developed a toolkit for blended English and technical literacy instruction, published reports on the human rights crises along the Northern Border and the status of English Language Learners in Washington schools, respectively, led the Washington Immigrant Rights Coalition, comprising over 80 partner groups, served in leadership roles on several national coalitions, including the National Partnership for New Americans, Rights Working Group and Fair Immigration Reform Movement, issued policy fact sheets based on substantiated research, and supplied policymakers and reporters with information on key issues. We consistently promote communications tools in multiple languages, including social media and traditional media outlets, with the goal of reaching and informing diverse communities.
