

Jon Thompson to work in Cambridge University. Jon joins David and Sarah Illman who began serving in 2011 and also Peter and Ilona

Greyling. These missionaries conduct seminars, lectures and also help edit publications. Their work can be seen in the website based in

Cambridge: [www.christianheritage.org.uk](http://www.christianheritage.org.uk). The organization also supports The Round Church which is the site for seminars and bible studies

for university students. The topics for the seminars are a variety of subjects but primarily focused on religion and the impact Christianity had

on early scientists and scholars and the significance of faith in everyday life for students.

In 2012 a number of other organizations based in the United Kingdom asked if Christian Heritage USA would act as a fiscal agent and accept

grant for other missionaries involved in Morphe Arts and also the United Christian Fellowship. Several foundations donation funds and these

monies were sent to other organizations who share the same mission of Christian Heritage but perhaps use a different method to achieve

their goals

Due to the small size of the organization and the costs involved, the organization does not have an audit. Donors give to the organization and

then on a monthly basis, donations are forwarded to support the missionaries who work under the laws of the United Kingdom. Other funds

are used to provide for publication expenses and in 2012, a mass printing of the Gospel of Luke was printed and distributed in the UK from

such funds. Other monies are used to sponsor lectures and other forums to exchange ideas on the practical role of religion in society and the

impact Christian thought had on the development of civilization. While Churches and a few organizations do make contributions many of the

funds come from individuals who donate monthly

The organization maintains only one bank account and has no endowment, interest bearing accounts or other assets. The Form 990 has

many questions that simply do not apply to such a small volunteer organization. Every effort has been made to provide proper and direct

information, but many things do not apply and could not apply to this organization.
