NALCAB supports local non-profit organizations that (a) focus on developing affordable housing and community facilities in low-and moderate-income communities, (b) support small businesses and neighborhood small business districts, and (c) provide consumer financial education NALCAB's services for local non-profits include building core organizational capacity, supporting program development, and providing pre-development assistance for a wide range of affordable housing and economic development projects In addition, NALCAB provides technical assistance to municipalities and states to effectively utilize funding that they receive from US HUD under entitlement programs, including CDBG, HOME and ESG, for community development, affordable housing and homelessness services In 2012, NALCAB provided technical assistance and training services to more than 90 non-profit organizations that provide asset-building services in low-and moderate-income communities in 32 states and the District of Columbia in addition to providing technical assistance to 4 cities NALCAB hosted national and regional convenings to address the needs and interests of asset building practitioners and aspiring leaders in the industry Through these events as well as through online activities, NALCAB facilitates information shanning and peer-to-peer learning among non-profit practitioners
