PAT TILLMAN WAS BORN IN SAN JOSE, CALIFORNIA IN 1976. HE ATTENDED ARIZONA STATE UNIVERSITY, AND IN 1998 WAS DRAFTED BY THE ARIZONA CARDINALS IN THE SEVENTH ROUND. IN JULY OF 2002, PAT PLACED HIS NFL CAREER ON HOLD TO SERVE HIS COUNTRY. FOLLOWING PAT'S DEATH IN 2004, WHILE SERVING WITH THE U.S. ARMY'S 75TH RANGER REGIMENT IN AFGHANISTAN, HIS FAMILY AND FRIENDS ESTABLISHED THE PAT TILLMAN FOUNDATION. THE MISSION OF THE PAT TILLMAN FOUNDATION IS TO INVEST IN MILITARY VETERANS AND THEIR SPOUSES THROUGH EDUCATIONAL SCHOLARSHIPS, BUILDING A DIVERSE COMMUNITY OF LEADERS COMMITTED TO SERVICE TO OTHERS. THE FOUNDATION IS A NATIONAL LEADER IN PROVIDING RESOURCES AND EDUCATIONAL SUPPORT TO VETERANS, ACTIVE SERVICEMEMBERS AND THEIR SPOUSES. AIDED BY A GRASSROOTS MARKETING EFFORT, THE FOUNDATION RECEIVED 1,280 COMPLETE APPLICATIONS FROM FEBRUARY 13, 2012 THROUGH MARCH 16, 2012. AFTER MONTHS OF CONSIDERATION AND THOROUGH CONSULTATION WITH 14 UNIVERSITY PARTNER INSTITUTIONS LEADING THE WAY IN STUDENT VETERAN SUPPORT SERVICES, 59 CANDIDATES (30 AT-LARGE, 29 THROUGH UNIVERSITY PARTNERS) WERE SELECTED TO JOIN THE FOURTH CLASS OF TILLMAN MILITARY SCHOLARS. DURING THE YEARS ENDED DECEMBER 31, 2012 AND 2011, THE FOUNDATION AWARDED 958,000 AND 816,500, RESPECTIVELY, IN SCHOLARSHIP SUPPORT. AS OF DECEMBER 31, 2012 AND 2011, THE BOARD HAS DESIGNATED 676,000 AND 591,500 IN FUNDS FOR ANTICIPATED SCHOLARSHIP FUND RENEWALS FOR CURRENT TILLMAN MILITARY SCHOLARS. TO DATE, 230 TILLMAN MILITARY SCHOLARS REPRESENTING 34 STATES AND ATTENDING 71 INSTITUTIONS NATIONWIDE HAVE BEEN AWARDED OVER 3.2 MILLION.
