The purpose of Voices for Global Change is to design, develop and implement educational, informational and training programs in transitional and developing countries, that strengthen and empower civil society. Our mission is to serve any group that has been marginalized from full participation in their country's social, economic and political life.

We train women from the former displaced persons camps of northern Uganda in a micro-enterprise project that provides them with a source of sustainable income. At present we have 25 women in the program. The project involves the creation of paper bead jewelry tht Voices for Global Change, through its Paper to Pearls initiative, sells in the United States and throughout the world.

4b (Code: ) (Expenses \$ including grants of \$ 13,030 ) (Revenue \$ 8,270 )

Voices for Global Change raised money his year in support of an orphanage in Takeo, Cambodia that provides for the education of 135 children and teenagers. This includes the opportunity for the older orphans to go to college or vocational school. This year all monies donated were sent to the Rob Abney Educational Fund, a non-profit founded in the memory of Voices board member, Ron Abney who instituted the Takeo support. The Fund will continue Voices' Takeo work.

This year Voices for Global Change contributed to the establishment of a new project in northern Uganda designed to teach the local community about the benefits of recycling. Called Recycling for Hope, the project worked in conjunction with other recycling efforts in Gulu, Uganda, hiring locals and raising environmental awareness among children in the community's public schools.

The monies used for project administration in Uganda support the Paper to Pearls poverty alleviation program described in Form 990, Part III. Time sheets of in-country project managers were submitted and managers are paid a monthly fee and reimbursement for documented expenses. The monies are typically sent via Western Union.

The monies donated to the Takeo Orphanage (\$13,021) were part of on-going support provided by Voices for Global Change former Vice-President Ron Abney, who began fundraising for the orphanage in the early 1990s. A separate Voices bank account was maintained for these funds and all disbursements to the Takeo representative (via international wire transfer) were recorded.

The same representative sent records of the use of all monies.

The second Uganda project was made possible by a one-time Voices donation. Since the monies for the project were raised from family, friends and associates of the project founder, no accounting was required. The founder was a previous project manager for the Voices for Global Change Paper to Pearls project and is well-known by Voices' president, Barbara Moller.
