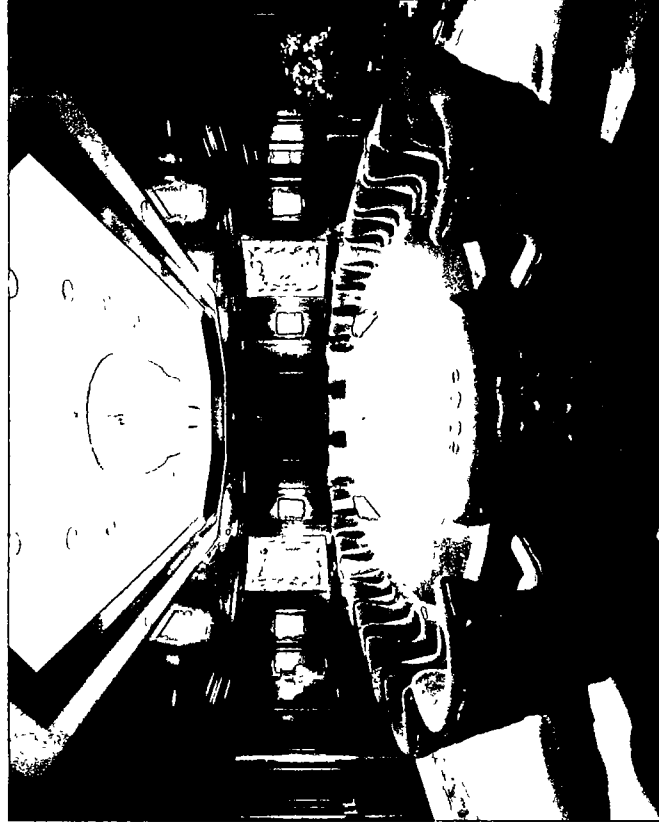

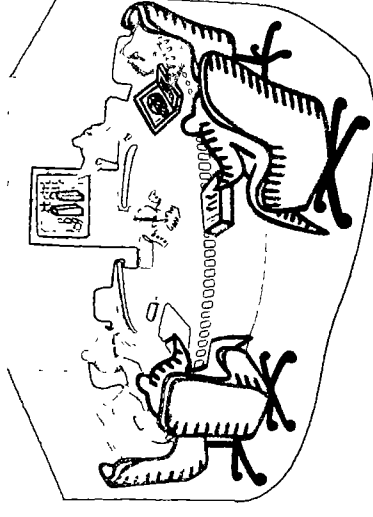

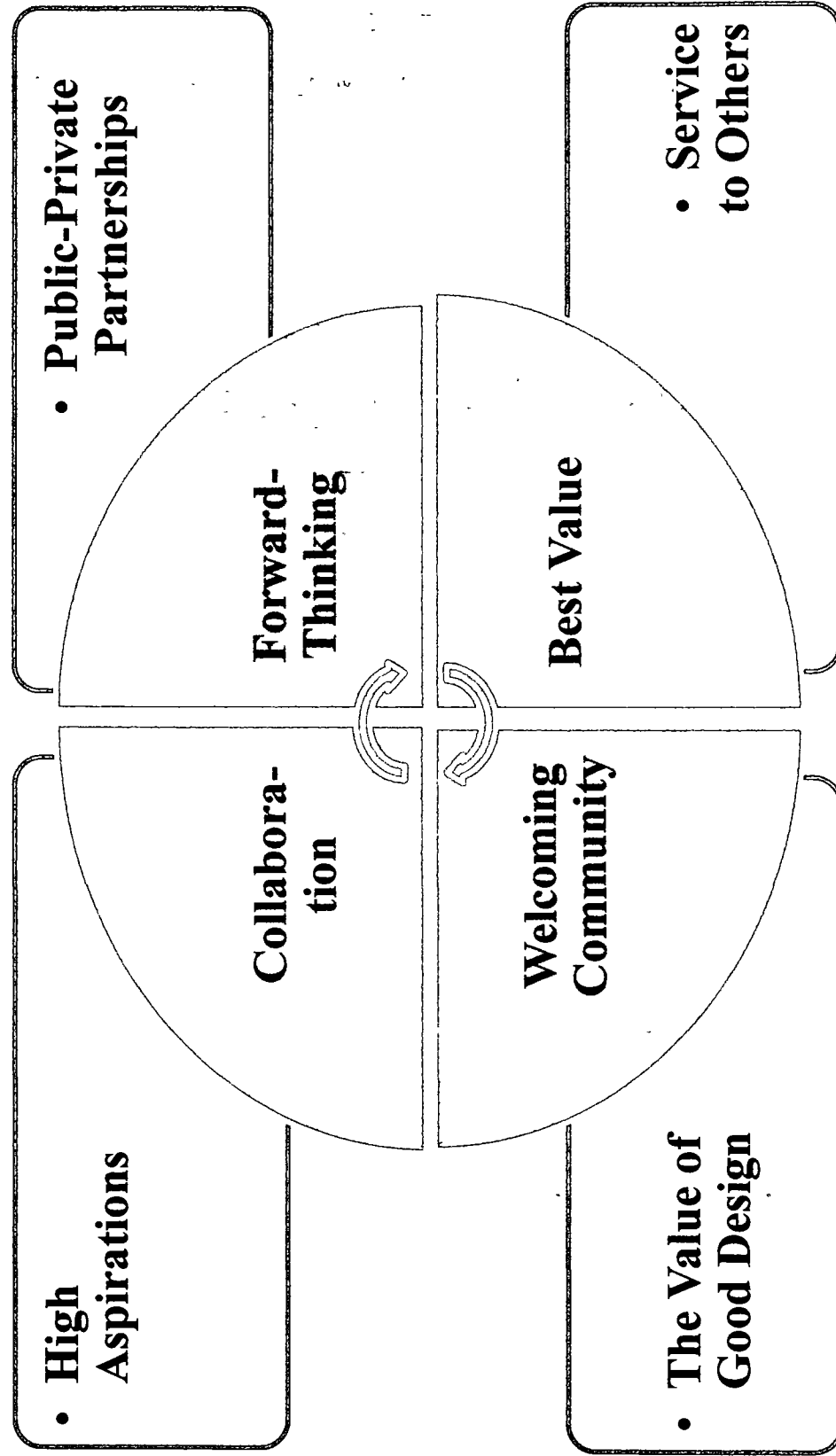

BOARD GOVERNANCE

THREE COMMON PATHWAYS

1) Appointed

- Authorizing individual or entity places a representative on a Board as its designated representative (*Example: Governor appoints 6 of the 9 members of IU-Bloomington's Board of Trustees; IvyTech Board members are appointed*)

2) Elected

- Board membership is by public ballot & the result of running for public office (*Example: City & County Councils, County Commissioners, School Boards*)

3) Nominated

- Self-perpetuating process of an organization to nominate and select its own Board members based on criteria it has established – e.g. diversity, geography, background/experience, skill sets (*Example: Community based organizations, social service agencies, private institutions, arts & athletic organizations*)

BOARD GOVERNANCE

A TEAM EFFORT

- Body of the Whole

- *Team Member* - Regardless of the pathway, once you join a Board you are part of a Team; it's about the Team & not self-interest.

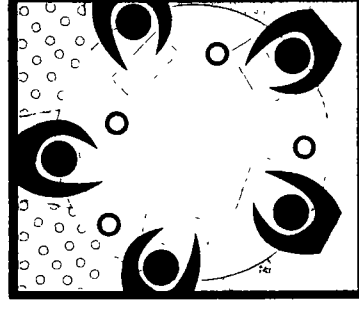
- *One Authority* – The power of the Board is as a unit; no one member has authority alone.

- *Board Type*

- Governing Board – ultimate, decision-making authority
 - Advisory Board – advise and counsel only

- *Three Legal Principles*

- Duty of Care
 - Duty of Loyalty
 - Duty of Obedience

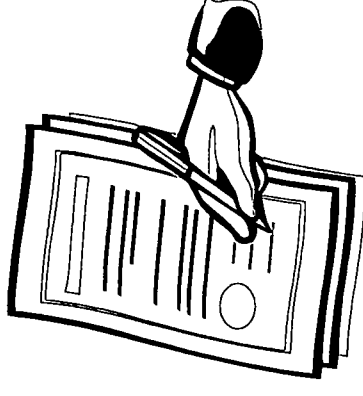


BOARD GOVERNANCE LEGAL PRINCIPLES

Three Duties of the Board of Directors

- **Duty of Care**—acting in good faith to make reasonable judgments and decisions with the care an ordinary or prudent person in a like position would exercise; making reasonable judgments.
- **Duty of Loyalty**—always doing what is in the best interest of the organization; avoiding conflicts of interests between organizational and personal interests.
- **Duty of Obedience**—honoring and acting consistently with the requirements of applicable laws and the organization's mission, by-laws, policies, and other standards of appropriate behavior.

BOARD GOVERNANCE A LEGAL CONSTRUCT



- Articles of Incorporation

- the originating papers to form the organization for a specific purpose

- By-Laws

- the “Rule Book” that outlines how the organization will operate

- Non-profit – 501(c)(3) tax-exempt status

- the status given by the IRS to organizations that have a charitable purpose & are exempt from federal income taxes
