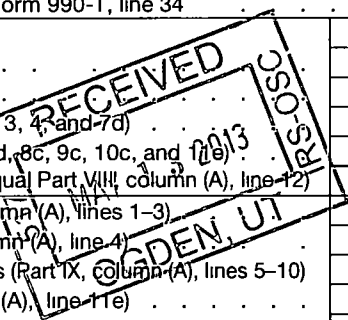

Prasadam distribution : In the last year, we distributed profuse quantity of prasadam (sanctified food) to all the visitors of our facility. On every Sunday, we serve feast to about 150 visitors. On every Saturday we serve about 50-100 visitors. On festival days (totalling 7) we served a total of 5000 visitors. And we went out in the Farmers market Sunnyvale area and the Palo Alto downtown area around 5 times each to distribute candys and sweets.

4b (Code: _____) (Expenses \$ 9112 including grants of \$ _____) (Revenue \$ 0)
FOLK programs : Conducted monthly and weekly FOLK sessions to people from all walks of life. These are basically community outreach programs like conducting personality enhancement workshops for attaining better focus in life, cultivate positive value systems, develop interpersonal skills, increase operational skills, and enhance personal growth. We introduced a special set of classes called 'Art of Self Discovery'. We conducted 12 such sessions last year. We also did our standard 'Art of mind control' 'Solving challenges in life', 'healthy eating habits and positive thinking', 'higher happiness through spiritual principles'. In total we had around 165 people attending these various sessions and they are giving nice feedback about the impact of these sessions.

Archana : One of the mission of the organization is to develop service attitude to the Almighty among all members. To achieve this, we installed wonderful archana process in our Sunnyvale facility in an organized manner. We have elaborate Archana standards and members of the organization follow some principles according to scriptures to make spiritual advancement. We were able to attract hundreds of new people to be able to visit our facility and do archana and have prasadam. Lot of people (this year around 125) have become regulars and are improving in spiritual life. Archana includes cooking food and celebrating the appearance days of the Almighty Lord etc. The expenses for this program included grant of \$22000 given to Vrindavanam Trust in India towards the archana process. India Heritage Foundation encourages similar faith organizations in U.S. and abroad to expound the same philosophy as propagated by H.D.G. A.C. Bhaktivedanta Swami Prabhupada, and as Vrindavanam Trust was deemed to follow the instructions of Swami Prabhupada, a grant was given to them to spread this process of archana. Also this expense includes the temple facility occupancy expense of \$49876 as archana requires the big hall for people to assemble and perform archana.
