THESE ADVISORS KEEP TRACK OF SCHOLARS GRADES AND SCHEDULES. THEY ARE AVAILABLE AND ON CALL TO THEIR STUDENTS WHEN THEY ARE IN NEED. ADVISORS MEET WITH EACH SCHOLARS AT LEAST TWICE PER SEMESTER, HELP THEM IDENTIFY OBSTACLES TO COMPLETING THEIR COLLEGE EDUCATION AND CREATE A PLAN TO OVERCOME THOSE OBSTACLES. THESE OBSTACLES COULD BE MONEY, FAMILY SUPPORT, BAD STUDY HABITS, LACK OF COLLEGE PREPARATION, HOUSING, EMOTIONAL ISSUES, ETC.
