Creative Santa Fe's (CrSF) 2012 public programming events, meetings, and community workshops addressed the fundamental question of how to enrich Santa Fe's creative economy with feasible strategies for tangible change. Our year of programming progressed from defining the challenges, assessing the available resources and collaborative opportunities, and ultimately gathering public input and expert advice about how to best proceed. Over 1,000 community members were involved. CrSF began in May with the controversial question "Evolve or Die?" In this panel discussion, CrSF brought experts from Glasgow, Scotland, and Buffalo, New York, to learn how other cities successfully compete internationally for cultural tourism and how they build vibrant creative economies under circumstances far more dire than that of Santa

10% Facts and Circumstances Test for Creative Santa Fe:

Creative Santa Fe received its IRS exempt status in 2005. Since the beginning, Creative Santa Fe normally received a substantial part of its support from governmental units (the City of Santa Fe, NM), from direct or indirect contributions from the general public, or from a combination of these sources.

The organization operated at a lower level of activity from 2008 until the fall of 2011. During that time, Creative Santa Fe maintained an active electronic newsletter, and list of 700 active members and friends, that it used to solicit contributions from the public, held public fundraising events to support programs, and applied for public grants and funding from governmental units.

In the fall of 2011, new board members and staff began working with the organization to reinvigorate its public programs and to develop new public initiatives. Creative Santa Fe has achieved the Ten-Percent-of-Support Requirement and the Attraction of Public Support Requirement on an aggregate basis in prior years and in 2012. Additionally, as discussed below, management believes Creative Santa Fe satisfies four of the Five Public Support Factors (the factor related to membership organizations does not apply). Creative Santa Fe's public support percentage for 2011 and 2012, both close to 30%, is near the required 33 1/3 % (public support percentage factor). Creative Santa Fe also changed its fiscal year in 2011, which resulted in a short 6-month fiscal year in 2011, shortening

the time available for fundraising and programmatic activity.

In 2012, Creative Santa Fe produced a very active series of four major public programs bringing nationally known leaders in creative industries to Santa Fe for workshops and public speaking events, receptions, and meetings. More than 1,000 people from the community participated in these events, which were publicly advertised through newspapers, radio announcements, and Creative Santa Fe's electronic newsletter that is sent to more than 3,000 people every month. Contributions to support these programs were solicited broadly from the public and targeted public and private sponsors. Fundraising solicitations methods include our website, newsletter, paperless post invitations, newspaper and radio ads, news releases, and individual solicitations by board members and staff.

Creative Santa Fe is organized and operated in a manner to attract new and additional public or governmental support on a continuous basis (sources of support factor). It has maintained a continuous and bona fide program for solicitation of funds from the general public and community, and it has carried on activities designed to attract support from governmental units or other charitable organizations. Partners in our public programming in 2012 have included the City of Santa Fe, the Santa Fe Arts Commission, Santa Fe Community Foundation, Santa Fe University of Art and Design, and the NM Department of Cultural Affairs. Some of these public organizations have supported Creative Santa Fe's programming with financial contributions and some of the contributions have been donated services. The public can also give Creative Santa Fe contributions through the organization's website www.creativesantafe.org.

Creative Santa Fe developed a Creative Business Resource Guide which is available free to the public and contains detailed information on the business resources available in this geographic region to people in the creative industries to improve their product development, get their work to market, and to improve their incomes. Creative Santa Fe participated in delivering workshops for artists to improve their business skills.

Creative Santa Fe's Board of Directors represents the broad interests of the public rather than the personal or private interest of a limited number of donors (representative governing body factor). The board members are very experienced with public organizations involved in visual, performance, and literary arts and culture. They represent the many varieties of arts and culture developed and practiced in Santa Fe and bring financial, managerial, and charitable organizational skills to the organization including many years of fundraising experience soliciting contributions from the general public.

Fe. Additionally, CrSF learned that creating a vital community for residents is the key to attracting tourists. Two specific outcomes from this event were CrSF re-igniting the city-wide conversations about city-wide branding efforts and focusing on moving forward on an affordable Arts and Creativity Center to support young creative workers.

In July, CrSF brought the renowned landscape designer Walter J. Hood to Santa Fe. Hood emphasized that Santa Fe has a powerful history and therefore needs to both celebrate its past while moving forward with innovative design. In order to build a vibrant city for Santa Feans, the community must look closely at how its residents and visitors already use city spaces, sidewalks, parks, and streets.

The August program with Jason Schupbach, NEA Director of Design, fleshed out a line of action. Schupbach provided specific examples of how other communities have developed public spaces through community activities and physical re-design. He laid out the national sources of funding for these projects and for CrSF's initiative to create affordable workspaces for artists.

In September, CrSF took the next step with Candy Chang's presentation about how art and design can build better communities. Chang sees social interaction and crowdsourcing as a basis for community infrastructure and when properly organized and tracked can be a

catalyst for residents to have a significant voice and impact in their neighborhoods.

Through workshops connected to its public programming, CrSF has identified three interrelated community actions: developing an Arts+Creativity facility; implementing a "Plaza-to-Plaza" project linking the Railyard to the historic downtown Plaza; and collaborating to brand an extended Santa Fe festival season stretching from spring through summer into fall.
