At the end of 2011, the City of Yakima recognized the benefits that had been provided for the previous three years by the Committee For Downtown Yakima and made the decision to handle the district's clean-up, plantings, graffiti removal, and the like more directly. However, putting the new city program in place did not happen immediately, and the City of Yakima continued to contract with the Committee For Downtown Yakima on a month to month basis for minimal services through June 30, 2012. During the first six months of 2012, therefore, a skeleton CDY crew continued to clean sidewalks, remove graffiti, maintain flowers and shrubs in season, monitor city-owned parking lots for overtime and illegal parking, and otherwise maintain similar common downtown infrastructure. Beginning July 1, 2012, the City of Yakima had a new program in place and CDY ceased all of the above operations. CDY is remaining as a totally volunteer organization of community leaders to provide downtown property and business owners with advice on marketing, exterior facade design, and whatever will improve the downtown business climate.

Part VI, Line 19 -- All financial records, conflict of interest policy, board minutes, and governing documents are available upon request through the corporate treasurer, who maintains the organizational files. Notification of such availability is in the organizational promotional materials.

Part XI, Line 9 -- The major decrease is net assets resulted from the transfer and sale of equipment CDY will no longer need. The lesser equipment (rakes, shovels, carts, etc) was sold and the sale price is reported on Part VIII, Line 7a. The reminder was actually purchased originally with funds derived from a special assessment paid by property owners in a the downtown Property & Business Improvement Area (PBIA). By Washington State Law, when CDY was no longer in need of the equipment, it must be transferred without cost to the governmental entity that established the PBIA--in this case, the City of Yakima, Washington. CDY, therefore, derived no financial gain from the transfer.
