Working Dogs for Conservation (WDC) helps save endangered species and habitats by integrating scientist-detection dog teams with research, management, and conservation initiatives. Over the last decade WDC has worked with other conservation biologists on nearly 40 species in 10 countries to address invasive species proliferation, climate change, energy development, habitat fragmentation, human / wildlife conflict, and the preservation and restoration of endangered plant and animal species.

During 2012, WDC collaborated with 15 conservation partners and worked in 4 states and 4 countries to collect species-specific information necessary for the preservation of wildlife and wild landscapes. WDC spent 635 days afield seeking 10 target species ranging from weeds in Montana, invasive beetles in Minnesota, to cheetahs in Zambia.
